# 1. Organizing Authority & Host

US SAILING Center of Martin County (USSCMC)

## 2. Rules

This regatta will be governed by the Racing Rules of Sailing (RRS).

# 3. Eligibility & Entry

- 3.1 The regatta is open to all boats of the Laser, Laser Radial and Laser 4.7 class.
- 3.2 Skippers may be entered by completing an entry form, registering with the organizing authority and paying the entry fee.
- 3.3 Age handicapping will NOT be used, but all ages are encouraged to participate.

# 4. Registration & Fees

- 4.1 The registration fee is \$80. Those registering prior to May 28, 2017 will receive a \$30 discount for an **entry fee of \$50**.
- 4.2 Registration will include two-hour clinic Friday afternoon from 4 PM- 6PM for all ages. Additionally, on-water coaching and support will be provided for up to 8 Junior Competitors who do not have a sailing coach. If you wish receive the coaching support, please select "Junior Coach Requested" when registering through Regatta Network.
- 4.3 Lunches, Dinners and post sailing beverages are the responsibility of the individual participants. The USSCMC deck may be utilized for social activities as the individual sailors wish.
- 4.4 Registration fees are non-refundable. Registrations the day of the event will be subject to a \$30 late fee for a total entry fee of \$110.
- 4.5 A lodging questionnaire will be a required document at check-in. This form will be made available online at <u>www.usscmc.org</u> on the "Upcoming Regattas" webpage and at check-in.

#### **6.** Sailing Instructions

Sailing Instructions will be posted on the website sometime prior to the event and will be available at check-in.

#### 7. Courses

Courses will be posted on the Official Notice Board and available in the Sailing Instructions.

### 8. Scoring

- 8.1 One race constitutes a regatta.
- 8.2 If 5 or more races are sailed, each boat's series score shall be the total of her race scores excluding her worst score.

### 9. Prizes

Prizes will be awarded to the top three finishers in Full, Radial and 4.7. There will also be an award for the oldest competitor and the youngest competitor who successfully completes all races.

### 10. Safety

All competitors shall wear U.S. Coast Guard approved lifejackets at all times while on the water. Failure to do so is protestable only by Race Committee and may result in disqualification.

### **11. Disclaimer of Liability**

Competitors participate in the regatta entirely at their own risk. See Rule 4, Decision to Race. The organizing authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during or after the regatta.
