# 1. RULES

- 1.1 This Regatta shall be governed by the rules as defined in the Racing Rules of Sailing, the J/22 Class Association Class Rules, The J/70 Class Association Rules and the J/105 Class Association Rules, The J/24 Class Association Class Rules, and T Ten Class Association Class Rules.
- 1.2 Class Rules regarding weigh-in shall be amended to allow boats to disclose crew weight in writing at registration on site. Weights may be checked during the Regatta to insure compliance. [DP]
- 1.3 RRS 61 is changed to include: "A boat intending to protest shall notify the RC Signal boat of her intention to protest and the class and sail number of the boat she is protesting, after clearing the finish line. She may do this via direct hail to the Signal Boat or by using the VHF radio channel assigned to her course.

# 2. ELIGIBILITY

The regatta is open to J/22, J/70, J/24, T Ten and J/105 Class boats with a valid measurement certificate on file with the Class Office and five boats registered before September 19, 2017.
