**Notice of Race**

#### **1. RULES**

- 1.1 This Regatta will be governed by the rules as defined in The Racing Rules of Sailing (RRS) 2013-2016 ([www.sailing.org](http://www.sailing.org)). To the extent permitted by Part 7 of the RRS, specific provisions of the RRS June be modified, altered or made inoperative by the Notice of Race (NOR) or the Sailing Instructions (SI).
- 1.2 Rules of participating ONE DESIGN (IC 24) class will apply, except as modified, altered or made inoperative by the NOR or the SI, to the extent permitted by such class rules.
- 1.3 If there is a conflict between languages the English text will take precedence.

#### **2. ENTRIES AND REGISTRATION**

- 2.1 Registration must be done in [www.regattanetwork.com](http://www.regattanetwork.com)
- 2.2 Registration Fee is \$100.00

#### **3. SCHEDULE**

- 3.1 Skippers check in and Registration
  - 3.1.1 At Club Nautico de San Juan, on Saturday June 3, 2017, from 0900 hours to 1000 hours. Competitors shall register at the Registration Desk located at "La Grua".
  - 3.1.2 All competitors must complete registration before the Skipper's meeting.
- 3.2 Skipper's Meeting
  - 3.2.1 The Skipper's Meeting will be at "La Grua" at 1000 hrs on Saturday June 3, 2017.

### 3.3 Races

#### 3.3.1 Races will be back to back.

Saturday, June 3, 2017

The first warning signal is scheduled for 1200 hours

Sunday, June 4, 2017

The first warning signal is scheduled for 1100 hours

#### 3.3.2 No warning signal will be hoisted after 1700 hours on Sunday.

## 4. SAILING INSTRUCTIONS

4.1 The sailing instructions will be available at registration time.

## 5. SCORING

5.1 A minimum of one (1) race will constitute a regatta

5.2 The Low Point System (A4) will apply.

5.3 When fewer than five (5) races have been completed, a boat's series score will be the total of her race scores.

5.4 When from six (6) to ten (10) races have been completed, a boat's series score will be the total of her race scores excluding her (1) worst score.

5.5 When from eleven (11) to fifteen (15) races have been completed, a boat's series score will be the total of her race scores excluding the worst two (2) scores.

## 6. ADVERTISING

6.1 ISAF regulation 20.4 applies. Boats must be required to display advertising chosen and supplied by the Organizing Authority (OA) in all or any of the races, if applicable.

## 7. CREW PER YACHT

7.1 Minimum crew per yacht in all classes shall be in accordance with the class rules. The number of crew must be declared on registration of the yacht. Any changes must be informed and permission obtained from Race Committee Chairman.

## 8. SAIL NUMBERS

8.1 All competitors are advised that same numbers will be required on mainsail and spinnakers.

## 9. AWARDS PRESENTATIONS

9.1 The awards presentations for CNSJ IC24 Championship will be held at the "Academia de Vela" on June 4, 2015 at 1700 hrs. Awards will be given for first, second and third place.

## **10. DISCLAIMER LIABILITY CLAUSE**

Competitors participating in the regatta are entirely at their own risk. Competitors agree to be bound by the rules as defined in The Racing Rules of Sailing (RRS), by Sailing Instruction (SI), the Notice of Race (NOR) and any additional information to the SI or to the NOR. Competitors agree to take any responsibility for nautical qualities of their yacht, the rigging, the crew ability and safety requirements. Competitors also agree to take any and all responsibility for damages caused to third persons (bodily injury included but not limited thereto) or their belongings, to themselves (bodily injury included but not limited thereto) or to their belongings, ashore and at sea as a consequence of their participation in the regatta, relieving of any responsibility The Club Nautico de San Juan and all his members, the sponsors and all persons involved in the organization under whatever qualification and to accept full responsibility for their behavior and dress of yacht's crew, representative and guest. Competitors are to be acquainted with RRS Part 1 Fundamental Rule 4: "The responsibility for a boat's decision to participate in a race or to continue racing is hers alone". In any case, competitors agree that The Club Nautico de San Juan Organization, the sponsors and their agents, have no responsibility for loss of life or injury to members or others or for the loss of, or damage to any vessel or property. As part of the registration process, each individual participating crewmember will be required to sign a declaration accepting this disclaimer of liability.

## **11. RIGHT TO USE AND LIKENESS**

11.1 By participating in CNSJ IC24 Championship a competitor automatically grants the CNSJ Dinghy Series Organizing Committee and its sponsors the right in perpetuity to make, use and show, from time to time at their discretion, any motion pictures and live, taped or filmed television and other reproductions of the competitor during the period of the CNSJ IC 24 Championship, without compensation.
