1. Organizing Authority & Host

2. Rules

This regatta will be governed by the Racing Rules of Sailing (RRS).

- The regatta is open to all boats of the Laser Standard, Laser Radial and Laser 4.7 class. 3.1
- 3.2 Skippers may be entered by completing an entry form, registering with the organizing authority and paying the entry fee.
- 3.3 Competitors must be current members of the Laser Class.

Prizes will be awarded to the top three finishers in Standard, Radial and 4.7. Special prizes may also be awarded including top master (over 35) in the Laser class. Additional awards and prizes may be presented at the sole discretion of the host and OA, and may be based on criteria other than the regatta.

All competitors shall wear U.S. Coast Guard approved lifejackets at all times while on the water. Failure to do so is protestable only by Race Committee and may result in disqualification.
