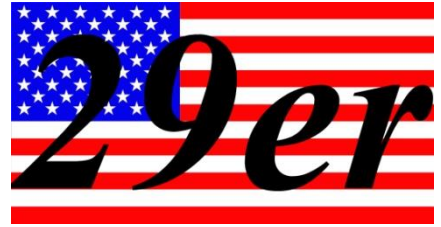


**MINOR WAIVER FORM**

**THIS FORM MUST BE AGREED TO PERSONALLY AND VOLUNTARILY BY A PARENT OR LEGAL GUARDIAN OF THE PARTICIPANT, IF THE PARTICIPANT IS NOT YET EIGHTEEN (18) YEARS OF AGE (I.E. MINOR), DURING THE EVENT.**

I am the parent or legal guardian of the above listed minor (herein "Minor") and I acknowledge and accept and authorize the following:

**MEDICAL AUTHORIZATION**

Such medical or dental treatment services or care which are necessary or appropriate for Minor, including the selection of medical personnel and facilities and transportation or transfer of Minor to such facilities and in connection with such treatment, services and/or care, to authorize and consent in my name and on my behalf to such emergency or necessary surgery, diagnostic or corrective, as they may determine to be necessary for the life, health or wellbeing of Minor, after reasonable consultation with duly licensed physicians, surgeons and /or dentists. It is understood that reasonable effort shall be made to contact me prior to rendering treatment of Minor but that any of the above treatment will not be withheld if I cannot be reached.

**WAIVER OF LIABILITY AND ACKNOWLEDGMENT OF ASSUMPTION OF THE RISK**

I also acknowledge that Minor intends to participate in the 2018 29er Midwinters East Regatta. I specifically assert that Minor will comply with racing rules and regulations governing the event. I will make certain that Minor is provided with a US Coast Guard or International 29er Class Rules compliant personal floatation device and will wear it as prescribed in the Notice of Race of this event. I am aware that participation in a sailing event presents the risk of serious injury and even death. I acknowledge that the risks exist and assume said risks for Minor with respect to practicing or participating in a sailing event either on the water, on the docks or on shore.

I hereby release 29er USA Class Association, US Sailing Center Miami, the their officers, directors, agents, trustees, servants, volunteers, sponsors, employees of any liability for bodily injury to Minor while he or she is participating in this and hereby acknowledge and assume the risk of any bodily injury to him or her while participating in or practicing for this event.

I grant the 29er USA Class Association and the US Sailing Center Miami the right to use Minor's name, age and photograph, and/or video without compensation, in any press release, web site posting, advertisement, brochure or other.
