



## NOTICE OF RACE

*The notation '[DP]' in a rule in the NOR means that the penalty for a breach of that rule may, at the discretion of the protest committee, be less than disqualification.*

### 1. RULES

- 1.1 This Regatta shall be governed by the rules as defined in the Racing Rules of Sailing, the J/22 Class Association Class Rules, The J/70 Class Association Rules and the J/105 Class Association Rules, and T Ten Class Association Class Rules.
- 1.2 Class Rules regarding weigh-in shall be amended to allow boats to disclose crew weight in writing at registration on site. Weights may be checked during the Regatta to insure compliance. [DP]
- 1.3 RRS 61 is changed to include: "A boat intending to protest shall notify the RC Signal boat of her intention to protest and the class and sail number of the boat she is protesting, after clearing the finish line. She may do this via direct hail to the Signal Boat or by using the VHF radio channel assigned to her course.

### 2. ELIGIBILITY

The regatta is open to J/22, J/70, T Ten and J/105 Class boats with a valid measurement certificate on file with the Class Office and five boats registered before September 14, 2018 .

### 3. REGISTRATION AND FEES

Registration shall be made through RegattaNetwork.com. Competitors shall check in at the regatta registration table (see schedule below) and sign a waiver form and weight declaration form to complete registration. [DP]

#### 5. SAILING INSTRUCTIONS

The *Sailing Instructions* will be available at registration and at Regatta Network in advance.

#### 6. VENUE

Racing will take place on the open waters of Lake Erie, North of Edgewater Yacht Club.

#### 7. SCORING

7.1 The scoring system will be in accordance with the *RRS Appendix A* except there will be no throw outs.

7.2 One race is required to constitute a series.

#### 8. GUEST DOCKAGE AND LAUNCHING

Launch and haul out travel lift service will be available free of charge for T Ten and J/105's arriving on trailers. Owners requiring the travel lift must call the Club Office (216-281-6470) in advance to make arrangements. J/22, and J/70 may use one of three self-service 2 ton hoists.
