

NOTICE OF RACE

TEXAS SAILING ASSOCIATION YOUTH CIRCUIT REGATTA

October 6-7, 2018

1. RULES:

- 1.1 The regatta will be governed by the *rules* as defined in *The Racing Rules of Sailing*.
- 1.2 “The Texas Youth Racing Circuit Conditions” apply and are available on the web site at <http://www.tx sail.org/> . A copy will also be available at the regatta site.
- 1.3 The rules for all classes are altered so that membership in a class organization is not required.
- 1.4 Racing Rules 61.1(a), Protest Requirements and Appendix A2, Scoring Systems are modified for this series as outlined in the Sailing Instructions. Racing Rule 49.1 is changed to allow the use of hiking pants.
- 1.5 The hosting club for this regatta is Dallas Corinthian Yacht Club (DCYC).

2. ADVERTISING:

- 2.1 Boats may be required to display advertising chosen and supplied by the organizing authority.

3. ELIGIBILITY:

- 3.1 The regatta is open to all boats of the Optimist, Laser (Full, Radial and 4.7), Open BIC, and Double-Handed (420 Club, 420 Collegiate, or other double handed boat as approved by DCYC) classes. All classes are “bring your own boat”, however, DCYC has a limited number of Optimist, 420 Collegiate and Open BIC boats. Contact the Regatta Chairperson to charter a boat. A minimum of three (3) boats is required to form a class. All boats shall have identifiable sail numbers. Sail numbers meeting class standards are encouraged.
- 3.2 The regatta is open to all junior sailors who are less than twenty years old and who do not turn twenty years of age during this calendar year.
- 3.3 Optimists are sailed in four fleets:
 - 3.3.1 Green Fleet: Open to all novice sailors under age 15 and through 12/31 of the calendar year in which they turn age 15
 - 3.3.2 White Fleet: Age 10 and under
 - 3.3.3 Blue Fleet: Age 11 – 12
 - 3.3.4 Red Fleet: Age 13 – 15
 - 3.3.5 For Optimist White, Blue and Red fleets, Skippers’ age on the first day of the regatta determines his or her fleet. Skippers move fleets on their 11th and 13th birthdays. Those turning 15 may continue in Red fleet through 12/31 of that year.

4. CLEAN REGATTA PARTICIPATION:

We are proud to announce that we have joined the race to restore ocean health with Sailors for the Sea’s Clean Regattas program. Protecting our local waters is very important to this regatta and we ask for your help in this effort. To learn more about this initiative visit www.sailorsforthesea.org.”

We ask for your help on the following items:

- Ensuring your recycling and trash are separated before disposing of waste in our marked disposal stations and recycling bins
- Competitors should the reusable water bottles that will be given to each of our competitors and utilize the water bottle filling stations located throughout the club
- Support personnel and spectators should bring reusable water bottles to use throughout the weekend

5. **ENTRY FEE:** The early registration entry fee is \$55.00 for each sailor, whether in single or double-handed boats. The entry fee will increase to \$60.00 on Monday, October 1, 2018. The entry fee includes one (1) regatta T-Shirt and the following meals for each sailor: breakfast, lunch and dinner on Saturday and breakfast and lunch on Sunday. Meal tickets will be available for non-competitors for an extra charge of \$20.00 for an all-inclusive wristband, or individual tickets for \$10.00 for Saturday dinner, and \$8.00 for Saturday or Sunday lunch. Additional t-shirts are also available for \$20.00. Registration is available online at www.txsail.org or www.dcy.org/pirates. If you prefer to mail in your registration, **please make all registration checks payable to DALLAS CORINTHIAN YACHT CLUB.**

6. **REGISTRATION AND CHECK IN:**

- 6.1 Pre-Registration is encouraged and may be completed online at www.txsail.org or www.dcy.org/pirates or by completing and sending the registration form located at <http://txsail.org/youth-sailing/forms/> to **Michele Ditmer, 1202 Cedar Pine Lane, Oak Point, Texas 75068** or micheleditmer@gmail.com.
- 6.2 Registration and check-in at the regatta will be conducted on Saturday, October 6, 2018 between 0800 and 0930 am in the clubhouse upstairs. Execution of a **Liability Release Agreement** as set forth in the Registration Form shall be required. Parents are urged to provide a signed **Medical Consent Form** to enable other adults to obtain emergency medical services in the event of the parents' unavailability during the regatta.
- 6.3 All sailors are **required to check in** by 0930 on Saturday at the registration table, even if the sailor pre-registered by mail or other means.

7. **SCHEDULE:**

- 7.1 Subject to the decisions of the Race Committee, six (6) or more races are scheduled. One (1) race will constitute a regatta. If five (5) or more races are completed, there will be one (1) throw out race for scoring purposes. If ten (10) or more races are completed there will be one (1) additional throw out – two (2) total – for scoring purposes.
- 7.2 The schedule for the regatta is:

0800 The Club will be open to allow unloading of boats.

Saturday, October 6th

0800-1000 Breakfast
0800-1000 Registration at the Clubhouse Upstairs
0930 Skippers' Meeting at the Clubhouse Upstairs (**Attendance Mandatory**)
1030 Warning Signal for the first race, additional races to follow
Between Races **Lunch will be served onshore or on the water at the discretion of the race committee**
0600 Dinner

Sunday, October 7th

0800-0900 Breakfast
1000 Preparatory Signal for the first race, additional races to follow
After Racing Awards ceremony

- 7.3 No warning signal for a race will be given after 1700 on Saturday and 1400 on Sunday.
- 7.4 **Attendance at the Skippers' Meeting held at 0930 on Saturday of the regatta is mandatory.**

8. **SAILING INSTRUCTIONS:** Sailing Instructions will be provided at registration and at the Skippers' Meeting. If published on time, they may also be posted at www.txsail.org or www.dcy.org/pirates.

- 9. VENUE:** Races will be conducted on the waters of Lake Lewisville.
- 10. SAFETY:** A U.S. Coast Guard approved personal buoyancy device will be worn by all competitors while on the water. Wet or Dry suits are not considered adequate buoyancy devices for this purpose. All buoyancy devices shall be worn on the outside of all clothing.
- 11. DISCIPLINE :**
- 11.1** Per US SAILING Regulation 5.03 no contestant shall use, either on or off the water, during any Texas Sailing Association Junior event: marijuana or any other controlled substance (as defined in 21 U.S. Code 802) the possession of which is unlawful under 21 U.S. Code 841, or alcoholic beverages (distilled spirits, wine and beer, each as defined in chapter 51 of the U.S: IRC Code and intended for beverage use). This regulation is in effect from date and time of arrival through date and time of departure from the locale. The penalty shall be that the contestant after a proper hearing, be immediately removed from the regatta venue and, where practical, sent home.
- 11.2** All competitors, coaches and parents are expected to maintain the highest level of conduct throughout the entire event. When the Protest Committee, from its own observation or a report received from any source believes that a competitor may have committed a breach of a rule, good manners, or sportsmanship, or may have brought the sport into disrepute, it may call a hearing. After a proper hearing the penalty may range from a reprimand to dismissal from the regatta and additional action may be taken under RRS 69.
- 11.3** Hearings will be held generally in accordance with the recommendations of Appendix M5 of the RRS. The officers for hearing a violation will consist of the Chief Judge, acting as chairman of the hearing, the Protest Committee and the Chairman of the Texas Sailing Association Junior Committee or his or her designee in the event he or she is not present. The regatta chair shall serve ex officio as a nonvoting member of the panel and will have an open right to express his or her views during the course of the hearing process.
- 12. TROPHY PRESENTATION:** Trophy presentations will be held on Sunday afternoon approximately one (1) hour after the last race or when protest hearing(s) are completed. The number of trophies will be determined by the number of entries in each fleet. Participation awards will be given to all Green Fleet sailors.
- 13. LODGING:** Camping is allowed on the DCYC premises. There is a limited number of RV spaces available at a first come/first served basis. DCYC has showers available.
- 14. DIRECTIONS TO THE CLUB:** From I-35E traveling North from Dallas, take Exit 458 – Swisher and turn right on Swisher. Continue about 2.6 miles over the Lake Lewisville Toll Bridge until you intersect with FM 720. Turn left on FM 720. Travel about 2 miles to McCormick (stoplight). Turn left on McCormick. Turn left at the first stop sign, Yacht Club Road. The club will be at the end of Yacht Club Road.
