Notice of Race



2019 Lido 14 Class Championships

July 19 - 21, 2019

The Organizing Authority for this event is Willamette Sailing Club. Lido 14 Fleet 25 (Portland, Oregon) is assisting the Organizing Authority.

The notation '[DP]' in a rule in the NOR means that the penalty for a breach of that rule may, at the discretion of the protest committee, be less than disqualification.

1) RULES

- a) The regatta will be governed by the rules as defined in The Racing Rules of Sailing.
- b) The following prescriptions of US Sailing will not apply: Rule 63.2 and Rule 63.4.

2) ELIGIBILITY AND ENTRY

- a) The regatta is open to all boats of the Lido 14 class that comply with the Lido 14 Class Association By-Laws.
- b) The registered skipper and crew shall sail the entire regatta together. If an emergency prohibits the crew from continuing thru the entire event, the skipper may use a replacement crew provided get approval from the Organizing Authority for the change. The replacement crew shall sail the remainder of the regatta. [DP]
- c) To enter, visit the event webpage on www.regattanetwork.com and complete the online entry process.
- d) Entries will not be accepted after 1000 hours (PDT) Saturday, July 20, 2019.
- e) A boat's entry will be considered complete when:
 - i) Online entry has been completed.
 - ii) Any applicable Liability Release and Parental Consent forms, for competitors not yet eighteen (18) years of age during the regatta, have been presented. The forms will be available on the event webpage.
 - iii) The registered skipper's membership in the Lido 14 Class Association has been verified.
 - iv) The registered skipper and crew have presented themselves at Registration/Check-In and completed all actions regarding weights and documents, as detailed in the NOR, have been completed.

3) FEES

- a) The entry fee for a boat with a skipper over the age of nineteen (19) is \$230, if received by July 5, 2019, and \$260 thereafter.
- b) The entry fee for a boat with a skipper not yet nineteen (19) years as of age as of December 31, 2019, is \$150.
- c) The entry fee provides two (2) T-shirts, two (2) Thursday night potluck meals, two (2) breakfast and lunch meals every race day, and two (2) Saturday dinner meals.

4) QUALIFYING SERIES AND FINAL SERIES

- a) The regatta will consist of a Qualification Series and a Final Series.
- b) The Qualification Series is scheduled to be a round-robin of flights that are seeded by the Organizing Authority.
- c) The Final Series will consist of Gold and Silver fleets.
- d) Boats will be assigned to Gold and Silver fleets per Lido 14 Class Association Bylaw ARTICLE XV, which assigns boats based upon their performance in the Qualifying Series.

5) SCHEDULE

- a) Maximum of three (3) races per flight are scheduled for the Qualifying Series.
- b) Eight (8) races are scheduled for each of the Gold and Silver fleets of the Final Series.
- c) The daily schedule of events is as follows:

6) MEASUREMENT/INSPECTION

- a) At Registration/Check-In, each skipper and crew shall present themselves, in normal sailing attire, for weighing.
- b) At Registration/Check-In, each boat shall:
 - i) Present a valid Lido 14 Class Association Official Certificate of Measurement and Registration for their boat
 - ii) Present the boat's main sail and jib sail for inspection of the Lido 14 Class Association sail royalty tag and the Fleet Measurer's stamps/signature/notations.
 - iii) Present a valid Boat Weight Verification Form, to be completed by the boat's fleet measurer or, by prior arrangement, by the organizers of this event. This form will be published on the event website no later than June 1, 2019.
 - iv) Present all ballast required to bring their boat and crew weighs up to the Class Association minimums; each boat's required ballast weight will be posted on the Official Notice Board prior to the start of racing.
- c) Boats without an Official Certificate of Measurement and Registration shall contact their Lido 14 Class Association Fleet Measurer to learn about acquiring one. On-site boat measurement for competitors without a fleet or a fleet measurer will be provided on an "by appointment only" basis on Thursday, July 18. Contact the Regatta Chair (see below) to make an appointment.
- d) The Organizing Authority may measure, weigh, or otherwise inspect any boat, her sails, or her equipment and/or her equipment before or after any race. [DP]

7) SAILING INSTRUCTIONS

a) The Sailing Instructions will be available at Registration/Check-In. They may be posted on the event website.

8) VENUE

- a) All on shore activities (e.g. Registration/Check-In) will be at Willamette Sailing Club, which is located at 6336 SW Beaver Ave, Portland, OR 97239.
- b) Races will be held on the Willamette River near Willamette Sailing Club.
- c) Boats may launch via the paved boat ramp adjacent to the clubhouse. It is recommended that boats not be stored in the water overnight, however they may do so if they so choose.

9) COURSES

The courses will be windward-leeward in shape using movable marks, the details of which will be specified in the Sailing Instructions.

10) SCORING

- a) For both the Qualification Series and the Final Series, the Appendix A Low Point Scoring System will apply, except that a boat's series score will be the total of her race scores in that series.
- b) One round robin of races of the Qualifying Series are required to be completed to constitute a series.
- c) Two (2) races of the Final Series Gold fleet are required to be completed to constitute a series.
- d) Two (2) races of the Finals Series Silver fleet are required to be completed to constitute a series.

11) MOORING/STORAGE

- a) A paved boat ramp to launch boats is provided (see image below).
- b) On-site parking for boat trailers is provided.
- c) Boats may moor overnight at the club's facilities however it is recommended that they not be left in the water as wakes from passing river traffic may result in boat damage.

12) PRIZES

Prizes will be awarded to both skipper and crew for:

- a) Top boat of the Qualifying Series.
- b) Top five (5) boats of the Final Series Gold fleet.
- c) Top five (5) boats of the Final Series Silver fleet.
- d) Lido 14 Class Association perpetual trophies.

13) DISCLAIMER OF LIABILITY

Competitors participate in the regatta entirely at their own risk. See Rule 4, Decision to Race. The Organizing Authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.
