

## WHITEBREAD 26 NOTICE OF RACE

Saturday 5 October 5 2019 (Foul Weather date October 6)

# 1. RACE DESCRIPTION AND ORGANIZING AUTHORITY

- 1.1. Whitebread 26 will be a handicapped distance race circumnavigating Shelter Island around government marks. The Race Committee will manage the division splits with the goal of improving competition at all levels. There will be awards for each division and for performance overall.
- 1.2. Organizing Authority: Peconic Bay Sailing Association.

## 2. COURSES, RENDEZVOUS & START TIMES

- 2.1. **Rendezvous** with an RC Vessel displaying code flag L in the vicinity of R18 in Little Peconic Bay. Code flag L means "Come within hail" and also "Follow Me". The location of the starting line may be adjusted according to the weather conditions.
- 2.2. Courses: The course for each sub division will be selected from the list of courses contained in the sailing instructions. Courses will vary in length up to 30 miles. Depending on the conditions, courses may not circumnavigate Shelter Island and may include government marks in Great Peconic Bay. Different divisions may sail different courses. All courses, unless shortened, will finish in the vicinity of Can 1 in Cutchogue Harbor. Courses may be shortened for some or all divisions for lack of wind or because of foul weather in accordance with RRS 32.
- 2.3. **Start Times:** The starting order and start times for each division and subdivision will be published in the SI's. The Race Committee intends to start the slowest yachts first prior to 0900 on 5 October.
- 2.4. **Postponements on Race Day:** The RC will hoist flags as required by RRS 27.3 and make efforts to inform competitors of its intentions on VHF. The failure of any competitor to receive such VHF messages shall not be grounds for redress.
- 2.5. **Postponement Prior to Race Day Due to Foul Weather**: the Race Committee will post on the official notice board Flags AP over A to announce the Race Committee's intent to postpone until 6 October or N over H to announce that racing on both days will be abandoned. The Race Committee will communicate with entrants by email.

### 3. RULES

- 3.1. Racing will be governed by the Racing Rules of Sailing (RRS) 2017 2020 except as modified here or by the Sailing Instructions.
- 3.2. **Decision to Race**: The responsibility for a boat's decision to participate in a race or to continue racing is hers alone as stated in RRS 4. RRS 82 shall not apply.
- 3.3. Scoring: Scoring for each division will be PHRF/Time on Time using PHRF of Eastern Long Island ratings.

- 3.4. **Division Flags**: Division Flags should be displayed on the backstay or stern of competing sailing vessels. Division Flags will be distributed in race packets at the Skippers'' Meeting on Friday. Division Flags will be used as class flags in the RRS 26 Starting Sequence. The purpose of this rule is to avoid confusion in the starting area and to allow competitors in each division to identify each other more easily on the race course.
- 3.5. **Conflicts:** In the case of a conflict between the Notice of Race and the SIs, the SIs shall govern. This modifies Rule 63.7.
- 3.6. **Protests and Redress:** The time limit is one hour after the last boat in the race finishes. The intention to protest shall be reported by hail or VHF to the Race Committee and shall include the sail numbers of the protested yacht or yachts. This modifies RRS 61.3 and 62.2. Protests and requests for redress must be submitted in writing within the time limit to the Protest Desk at Cutchogue Harbor Marina.
- 3.7. **Penalties**: In the spirit of Corinthian sailing, competitors are encouraged to take "turns" penalties at the time of the incident as specified in RRS 44.1 and 44.2. Failure to take turns does not preclude a competitor from taking a Scoring Penalty by displaying a yellow flag from the time of the incident until finishing and informing the Race Committee after finishing as required in RRS 44.3 (b)
- 3.8. **Protest and Redress Hearings**: Valid protests as defined by RRS 61 and RRS 62 will be heard in the Protest Room at Cutchogue Harbor Marina as soon as practical after the boats involved have finished. This changes RRS 63.1.
- 3.9. **Official Notice Board**: Changes and amendments to the NOR and the SIs and for protest notices will be accessible on line through <a href="www.pbsa.us">www.pbsa.us</a>. Reasonable efforts will be made to inform competitors via email of new postings to the <a href="Official Notice Board">Official Notice Board</a> on the event web site. Failure to receive such alerts shall not be grounds for redress. Oral changes to the sailing instructions may be given by the Race Committee on the water in accordance with RRS 90.2 (c). Every attempt will be made to inform competitors of such changes by VHF. Failure to receive such instructions shall not be grounds for redress.

First three places in each division and special awards as listed on the PBSA website.

## 6. ELIGIBILITY AND ENTRY

6.1. Mono hull or multihull sailing vessels of 22 feet length overall or greater as defined by PHRF of ELI with a valid 2019 PHRF of Eastern Long Island rating of 300 or less. The Whitebread race entry form must be completed on line. Payment may be made on line or by mail to PBSA, P.O. Box 1196, Cutchogue, NY 11935. The link to the entry form will be available on www.pbsa.us Entry shall be made to either the spinnaker, non spinnaker, or one design Fleet/Class. Division splits will be made by the race committee based on ratings and other criteria in order to improve competition and assign start times. One design classes will be assigned to PHRF divisions as appropriate for the purpose of determining overall awards.

- One design classes with at least three entries will also be scored in their own sub division. The results of these Race Committee decisions will be published in the SIs.
- 6.2. A valid 2019 rating certificate from PHRF of Eastern Long Island shall be submitted in order for a yachtto be scored. Yachts without PHRF of ELI ratings may apply for day ratings at www.phrfeli.org. The day rating fee is included in the WB26 entry fee. Entry shall not be complete until a valid PHRF rating has been received. However, if a yacht's rating appears on the 2019 PHRF of ELI Fleet Roster (valid list). There is no need to submit a separate rating form.

#### 7. FEES AND DEADLINES

September 4 (2400)	\$80.00 early bird entry and first timer \$50.00 entry end. All entries after midnight will be \$110.00.
September 15 (2400)	Last day to order gear to be picked up prior to the race. Last day to order discounted party tickets.
October 1 (2400)	Late entry deadline. Changes between divisions will not be accepted.
October 2 (2400)	Entries of boats without ratings will be cancelled and entry fees refunded.

- 8. **Entry Fees and Party Tickets**: *If you are entering the Whitebread for the first time, the entry fee is \$50.00*. The fee for all entries after September 4 is \$110.00. All party tickets are \$30.00 in advance of September 15 and \$40.00 thereafter.
- 8.1. **Refund of Entry Fee or Party Tickets**: No fees paid for party tickets shall be refunded after 2400 hours on September 15. Requests in writing for party ticket refunds should be submitted to the Regatta Co-Chair <u>Bill Coster</u>. Race entry fees of yachts submitting <u>written notice of withdrawal to the Principle Race Officer</u> prior to midnight on October 3 may be refunded on a case by case basis. After midnight on October 3, abandonment of racing by the race committee due to weather conditions shall not be sufficient reason to refund entry fees.

## 9. SAILING INSTRUCTIONS AND RACE PACKETS

- 9.1. Race Packets will be distributed at the Skippers' Meeting on Friday. Race packets will include a backstay division flag, sailing instructions, and a scratch sheet.
- 9.2. General Sailing Instructions: Sailing instructions will be posted on the event website in early September.
- 9.3. **Division Splits and Start Sequence Times:** Following the October 1<sup>st</sup> deadline for late entries and division changes, division splits and start times will be published on the event web site and in the SIs.
