# 1 ORGANIZING AUTHORITY

The Organizing Authority is the Beverly Yacht Club.

#### 2 RULES

This regatta will be governed by the current Racing Rules of Sailing (RRS), with US SAILING Prescriptions, including Appendix V, except as changed by this Notice of Race or by the Sailing Instructions.

# 3 ELIGIBILITY AND ENTRY

- **2.1** This regatta is open to all Shields Class sailboats in Fleet #10 (Marion) and Fleet #8 (Edgartown). A minimum crew of three persons is required.
- **2.2** Eligible boats may enter by registering online through Regatta Network's <u>"Island Bay Challenge Regatta"</u> event site by 1200 on the day before the race.

Racing will occur in Sippican outer harbor, in the vicinity of BYC buoys "A," "G," or "E."

#### **8 THE COURSES**

- **8.1** The courses will be windward/leeward type, typically between 3 and 6 miles in distance. Either around-the-buoys or drop mark courses will be used.
- **8.2** As many races as possible will be run each day.

### 9 SCORING

One race completed will constitute the event. The Low Point Scoring System of RSS Appendix A will apply. There will be no score discards.

# 10 RADIO COMMUNICATIONS

The Race Committee will communicate via VHF ch. 72. BYC launch service can be hailed on VHF ch. 68.

Fleet #10 will provide a prize for the winner at Beverly Yacht Club after sailing on Sunday.
