


# \*\*\* Notice of Race \*\*\* Blue Water Regatta

American Legion Yacht Club Saturday, September 21, 2019



## 1. ORGANIZING AUTHORITY

- 1.1. American Legion Yacht Club (ALYC) is the organizing authority for the Blue Water Regatta.
- 1.2. This race will run in conjunction with NYCLB All Hands Regatta.

#### 2. RULES

- 2.1. The regatta will be governed by the 2017-2020 Racing Rules of Sailing (RRS) as adopted by the United States Sailing Association (USSA) and the Class Rules of the Performance Handicap Racing Fleet of Southern California (PHRF), and the Notice of Race, except as altered by the Sailing Instructions.
- 2.2. The race is classified as a Category "A" Event in accordance with ISAF Regulation 20
- 2.3. Boats are subject to inspection by the appropriate fleet coordinator to ensure conformity to the applicable class rules, bylaws and/or measurement certificates.
- 2.4. RRS 55 is changed by adding the following sentence to the rule: "However, discarding elastic or wool bands when setting a sail is permitted."
- 2.5. US Sailing Safety Equipment Requirements (USSER) apply, Category US Nearshore. The USSER can be found at: <a href="http://www.ussailing.org/safety/equipment-and-requirements">http://www.ussailing.org/safety/equipment-and-requirements</a>.
- 2.6. In addition to USSER, all boats shall carry a functioning GPS.

#### CLASSES

- 3.1. The fleet will be divided into appropriate classes based on their Base Random Leg Course (RLC) Ratings.
- 3.2. There will be a PHRF Non-Spinnaker class based on the boat's PHRF Base Random Leg Course (RLC) Rating plus its Non-Spinnaker Offset.
- 3.3. There will also be a separate Non-Spinnaker Cruising Class.
- 3.4. Boats entering the Cruising Class are eligible for adjustments to the boat's RLC Rating.

#### 4. ELIGIBILITY

- 4.1. Each non-Cruising Class entrant must be a member of PHRF of Southern California, have a valid rating certificate, and be a member of a SCYA Member Yacht Club or a USSA recognized yacht club if not a resident of Area J.
- 4.2. Cruising Class racers need not be members of PHRF. This changes RRS 75.1.
- 4.3. ALYC will assign an arbitrary rating to any Cruising Class boat without a PHRF rating.

# 5. ENTRIES AND FEES

- 5.1. Online entry at US Sailing's Regatta Network website.
- 5.2. The entry fee is \$30.00 when received prior to 5:00pm (PDT) on the Wednesday immediately prior to the race. An additional late entry fee of \$10.00 is automatically added by Regatta Network after that date and time.
- 5.3. Cruising Class entrants without PHRF Certificate are required to submit a completed and signed Cruising Class Rating Form (Appendix A) to the Race Committee Chair via email (<a href="mailto:race@alyc.com">race@alyc.com</a>).

# 6. SAILING INSTRUCTIONS

6.1. Sailing Instructions will be available after 5:00pm (PDT) on the Wednesday prior to the race and will be posted to the ALYC website (<a href="www.alyc.com">www.alyc.com</a>) and on Regatta Network.

# 7. SCHEDULE

- 7.1. The race is scheduled to be sailed Saturday, September 21, 2019.
- 7.2. Any changes to the schedule of race will be posted by 7:00pm (PDT) on the day before the race on the bulletin board at the ALYC Hut and the Navy Yacht Club of Long Beach, on the ALYC website and on Regatta Network.
- 7.3. **The NYCLB All Hands Regatta Classes will START FIRST** with their first class warning signal scheduled for 11:55am (PDT) on Saturday, September 21, 2019.
- 7.4. The Blue Water Regatta classes will start AFTER the NYCLB All Hands Regatta with their first class warning signal approximately 12:15pm (PDT).

# 8. COURSES TO BE SAILED

- 8.1. Courses with Government Navigation Aids and Oil Islands as rounding marks may be specified.
- 8.2. Start Line will be between two marks each with an orange flag and one could be on the Committee Boat and located approximately 400 yards West of Oil Island Chaffee.
- 8.3. Finish Line will be west of the Newport Pier.

## 9. PENALTIES

9.1. The 720 degree turn penalty (RSS 44.1) is modified to a 360 degree turn.

# 10. SCORING

10.1. Scoring will be according to RRS A4.1 Low Point System.

- 11.1. Slips, moorings and parking: ALYC Guest Dock is available for loading and unloading only. Moorings and transit slips are available through Newport Marina Park, (949) 270-8159. Parking is available on Balboa Blvd, Bay Ave, and along 15<sup>th</sup> St.
