5. SCHEDULE OF RACES

- 5.1 Date of Racing: Saturday, June 20, 2020. PLEASE NOTE THIS IS A MAJOR SCHEDULE CHANGE.
- 5.2 These races will be sailed following the completion of the Pensacola Yacht Club (PYC) Fiesta of Five Flags/Cancer Society Regatta earlier in the day.

Scheduled warning signal times:

1055 - First PYC 5 Flags/Cancer Society Regatta race of the day.

1345 - NYCP Commodore's Cup #2 1500 - NYCP Commodore's Cup #3

6. CLASS FLAGS

6.1 Class flags will be:

Spinnaker A Pink
Spinnaker B Light Blue
Non-Spinnaker Purple

8. THE COURSES

- **8.1** The Spinnaker courses to be sailed will be windward/leeward using dropped marks.
- **8.2** Non-Spinnaker courses to be sailed will be windward/leeward (L) using dropped marks or designated government mark courses.

9. MARKS

- **9.1** The starting and finishing marks will be a red tetrahedron and an orange flag on the signal vessel.
- **9.2** For the dropped marks courses, Mark 1 (windward) and Mark 2 (leeward) will be orange tetrahedrons. Replacement marks will be yellow tetrahedrons.
- 9.3 For the government marks courses, marks will be displayed on the stern of the signal vessel.

11. THE START

First start: Spinnaker (all divisions) Second start: Non-Spinnaker

14. TIME LIMITS AND TARGET TIMES

14.1 Time limits and target times are as follows:

Mark 1 45 minutes - Time limit for the first boat to pass Mark 1.

Race Time Limit 2 ½ hours - Time limit for the first boat to sail the course and finish.

Finishing Window 45 minutes - Time limit for boats to finish after the first boat sails the course and

finishes.

- **14.2** If no boat has passed Mark 1 within the Mark 1-time limit, the race shall be abandoned. Failure to meet the target time will not be grounds for redress. This changes RRS 62.1(a).
- **14.3** If no boat has sailed the course and finished within the race time limit, the race shall be abandoned. Failure to meet the target time will not be grounds for redress. This changes RRS 62.1(a).

14.4 Boats failing to finish within the finishing window shall be scored Did Not Finish (DNF) without a hearing. This changes RRS 35, A4, and A5.

15 PROTESTS AND REQUESTS FOR REDRESS

15.3 Race committee boat is provided by PYC so will return to PYC upon completion of the final race.
