Southern Yacht Club (SYC) is the Organizing Authority (OA). This regatta will be run in conjunction with the SYC Handicap and One-Design Fall Series. Fall Series entrants may sail in this event at no charge, but will not be eligible for the awards or benefits of entry in this event.

1. RULES

The sailboat races will be governed by The Racing Rules of Sailing (RRS) with US Sailing Prescriptions, this Notice of Race, and the SYC General Sailing Instructions, which are available at <u>www.southernyachtclub.org</u>. Boats entered in the SYC Fall Series shall also be governed by the NoR for that series.

2. FLEETS

HANDICAP: ORR-Ez (Open, Classic, Classic Non-Spinnaker classes), PHRF (Spin & Non-Spin classes), and Multihull. Class definitions and breaks will be aligned with the SYC Handicap Fleet Fall Series. Additional classes may be added as entries warrant. Four valid entries are necessary to establish a class. Two Open and one Classic races are scheduled. Class starts may be combined at the discretion of the RC.

ONE DESIGN: Four valid entries are necessary to establish a class. Up to five races may be attempted.

OPTIMIST, DINGHY & DF65: Four valid entries are necessary to establish a class. Multiple races will be attempted.

3. RACE FORMAT & LOCATION

All sailboat racing will be conducted on custom courses with fixed or temporary marks on the South Shore of Lake Pontchartrain approximately one (1) nautical mile north of SYC.

4. ADVERTISING

Boats may be required to display advertising chosen and supplied by the organizing authority.

5. ELIGIBILITY

COMPETITORS: The race is open to all. Competitors need not be a member of a yacht club.

HANDICAP FLEET: Participating Handicap boats must have a valid rating certificate issued by Gulf Coast ORR-Ez or GYA PHRF, except as allowed herein. Boats entering the ORR-Ez Division must also be registered in the SYC HC Fall Series. Boats without a valid rating will be assigned a provisional PHRF rating by the Race Committee at its sole discretion and which is not subject to protest.

6. ENTRY FEES

Please register early for this worthy cause so that the event can be properly planned.

- Handicap & One-Design classes \$100 per boat.
- Dinghy classes\$45 per boat.
- Optimist & DF65 classes \$30 per boat.
- HC & OD Fall Series <u>sailing only</u>......No fee required.

The Entry Fees are the minimum amount requested to participate in the event. <u>Additional fundraising particip-</u> <u>ation for this worthy cause is encouraged.</u> Each paid entry includes racing and one (1) personal fundraising website. Each \$100 entry includes one (1) ticket to the VIRTUAL Party on Lake Pontchartrain on Saturday, October 3rd. <u>Additional Party tickets are available for \$100 each.</u> The Party on Lake Pontchartrain includes a Gosling's Rum Dark & Stormy Kit, live music, and silent & live auctions.

- Class Participation Award presented to the Class with the highest number of fund raising participants.
- Optimist Green Fleet will receive participation awards.
