Amendments in Red

11. MARKS

11.1. Course A (long)

11.1.a. "DH" is the red Diamond Head buoy.

11.1.b. "M1" is an inflatable orange tetrahedron **or cylindrical buoy**. The approximate GPS coordinates for **M1** will be **21° 16.183' N, 157° 43.416' W** **or within 2 nm of those GPS coordinates**. If **M1** is missing or out of position, the race committee boat may substitute for the mark in accordance with RRS 34.

11.1.c. "R2" is the red Ala Wai Harbor Channel entrance buoy.

11.1.d. The starting mark will be between an orange inflatable buoy and the Race Committee Boat. Instruction 11.2 will describe the starting line.

11.1.e. The finishing mark will be between an orange inflatable buoy and the Race Committee Boat. Instruction 12.1 will describe the starting line.

11.1.f. R2 will be used as a starting or finishing mark in the absence of an orange inflatable buoy.

11.2. Course B (short)

11.2.a. "DH" is the red Diamond Head buoy.

11.2.b. "M1" is an inflatable orange tetrahedron **or cylindrical buoy**. The approximate GPS coordinates for **M1** will be **21° 15.933' N, 157° 45.755' W**

or within 2 nm of those GPS coordinates. If **M1** is missing or out of position, the race committee boat may substitute for the mark in accordance with RRS 34.

- 11.2.c.** “**R2**” is the red Ala Wai Harbor Channel entrance buoy.
- 11.2.d.** The starting mark will be between an orange inflatable buoy and the Race Committee Boat. Instruction 11.2 will describe the starting line.
- 11.2.e.** The finishing mark will be between an orange inflatable buoy and the Race Committee Boat. Instruction 12.1 will describe the starting line.
- 11.2.f.** R2 will be used as a starting or finishing mark in the absence of an orange inflatable buoy.

16. PROTESTS AND REQUESTS FOR REDRESS

16.1. Protest forms are available from the race committee or on the HYC official bulletin board. Protests and requests for redress shall be delivered to the race committee within the appropriate time limit.

16.2. The protest time limit is 90 minutes after the last boat in the race has finished.

16.3. Notices ~~will be posted within 30 minutes of the protest time limit~~ to inform competitors of the time and location of hearings in which they are parties or named as witnesses **will be posted when the date, time and location of the hearing becomes available.**

16.4. Notices of protests by the race committee or the protest committee will be posted to inform boats under RRS 61.1(b).

16.5. A list of boats that, under instruction 13, have acknowledged taking a penalty or retiring, will be posted before the protest time limit.
