NOTICE OF RACE

1. RULES

- **1.1.** The regatta will be governed by the rules as defined in:
 - **1.1.1.** The Racing Rules of Sailing (RRS).
 - **1.1.2.** The current PHRF regulations, as administered by YRA of Long Island Sound (YRALIS) including non-spinnaker regulations for PHRF classes.
 - **1.1.3.** Crew Limit: For all divisions, LOA +3 format will be used. Take the first digit of the LOA & add 3. Ex. Boats under 30' LOA 5 crew, Boats 30' to under 40' 6 crew, etc.
 - **1.1.4.** US SAFETY EQUIPMENT REQUIREMENTS (SER), Nearshore Category.
 - **1.1.5.** Competitors are expected to abide by state and local health guidelines.
 - **1.1.6.** The COVID-19 Pandemic brings special considerations to yacht racing. It is the responsibility of each skipper to interpret, follow and enforce governmental guidelines regarding the Pandemic on their boat.
 - **1.1.7.** Current class rules for one-design fleets.
 - 1.1.8. RRS Appendix V Sections 1 & 2.
- **1.2.** The following racing rules will be changed. The changes will appear in full in the sailing instructions. The Sailing Instructions may also change other racing rules.
 - **1.2.1.** RRS 28.2 is modified to define areas that are obstructions (SI 11.1).
 - **1.2.2.** RRS 33(a & b) are changed such that the direction and distance to the mark will be announced on VHF channel 72.
 - 1.2.3. RRS 44.1 "Penalty at the Time of an Incident" is modified as specified in RRS V1.
 - **1.2.4.** RRS 62.1a is amended to add "Failure of a boat to see or hear her recall notification and the timing and order of such hail shall not be cause for redress."
 - **1.2.5.** RRS 61.1(a) is amended to include "A boat initiating a protest shall immediately after finishing, notify the race committee over VHF channel 72 of its intent to lodge a protest and the identity of the boat(s) being protested. Repeating the notification at [reasonable] intervals until acknowledged by the race committee."
 - **1.2.6.** RRS 61.1(a) is amended to include "A boat initiating a protest shall immediately after finishing, notify the race committee over VHF channel 72 of its intent to lodge a protest and the identity of the boat(s) being protested. Repeating the notification at [reasonable] intervals until acknowledged by the race committee."
 - **1.2.7.** 62.2 are changed such that the time limit for protests is 1800 hrs. on the day of the race.
 - **1.2.8.** RRS 35, RRS A4, and RRS A5 are modified to include a finishing time limit window.

2. ELIGIBILITY AND ENTRY

- **2.1.** The regatta is open to boats of PHRF (spinnaker, non-spinnaker, and cruising canvas), and One-Design classes of at least 21' LOA.
 - **2.1.1.** Eligible boats can enter and electronically pay the entry fee using the Lloyd Harbor Yacht Club's online registration at www.lhyc.org, following the link to the Race Information page.
 - **2.1.2.** The final deadline for entries is 1800 hrs, September 10, 2020.
- **2.2.** Entrants must possess a valid YRALIS PHRF certificate, a valid one-design certificate, or receive a waiver and LHYC handicap rating from the LHYC Measurer.
- **2.3.** If fewer than four entries are received for any one-design class, they will be entered in an appropriate PHRF class unless they wish to withdraw their entry.
- **2.4.** The intent of the Cruising Canvas division is that all sails will be of woven polyester such as Dacron, no spinnakers, gennakers, or Code 0 sails may be used.
- 2.5. No boat shall make any change during the regatta which would affect its rating.

3. FEES

- **3.1.** The early registration fee of \$70 is available to boats registering and paying through September 7st.
- **3.2.** For entries received after September 7th the full entry fee of \$85 is required.
- **3.3.** US Sailing members receive an additional \$5 discount.
- **3.4.** Fees should be paid be paid online during registration, but may be paid by check if necessary, made out to the Lloyd Harbor YC, P.O. Box 60, Huntington, NY 11743. Please contact the LHYC Fleet Captain prior to the race if you are planning on paying by check. Unpaid entrants will not be scored.

4. SCHEDULE OF RACES

- **4.1.** Racing is scheduled for Saturday, September 12, 2020.
- **4.2.** The scheduled time for the first warning signal of the Katrina Cup is 1100 hrs.
- **4.3.** The Winkle Cup Race will begin as soon as practicable after the Katrina Cup Race.
- **4.4.** No warning signal will be made after 1500 hrs.

5. SAILING INSTRUCTIONS

- **5.1.** The sailing instructions will be available on the LHYC club web site by September 7th at 1800 hrs.
- **5.2.** Scratch Sheets will be available on the web site no later than 1800 hrs, the day prior to the event. The Regatta Network "Current Registrants" list is NOT the Scratch Sheet.

6. VENUE

6.1. The venue is Huntington Bay and Long Island Sound outside Huntington Bay, Long Island, NY. The starting area will be, in the vicinity North of Bell "8", but no further than one mile north of Nun "6" off Lloyd Neck.

7. COURSES

- **7.1.** The course for all classes will be indicated by the race committee and be comprised of a combination of government and/or temporary marks.
- **7.2.** It is the intention of the race committee to prefer windward-leeward courses for PHRF and one-design classes, and navigation courses for JAM and Cruising Canvas, conditions permitting.

8. PENALTY SYSTEM

8.1. RRS 44 is modified as specified in RRS Appendix V1 & V2.

9. SCORING

9.1. Time allowances will be as per YRALIS PHRF procedures using time on distance and will be based on the course distance as calculated by the RC, regardless of the distance sailed.

10. RADIO COMMUNICATION

- **10.1.** Each boat shall carry a VHF radio capable of transmitting and receiving on channel 72.
- **10.2.** Except in an emergency, a boat shall neither make radio transmissions while racing nor receive radio communications not available to all boats. This restriction also applies to mobile telephones.

11. PRIZES

- **11.1.** Prizes in each race will be awarded as follows for each class: First if three or more competitors, Second if five or more and Third if seven or more.
- **11.2.** The name of the first place finisher in each division of the Winkle Cup race will be placed on the Winkle Cup Trophy, which is on permanent display at Centerport Yacht Club.
- **11.3.** The Byers Trophy will be awarded to the best PHRF spinnaker boat with the lowest overall corrected time in the Winkle Cup race.
- **11.4.** The Katrina Cup will be awarded to the best PHRF spinnaker boat with the lowest overall corrected time (one year retention of the trophy) in the Katrina Cup race.
- 11.5. The Katrina Cup Race is a qualifying race for the Schuster Trophy awarded to the best overall Lloyd Harbor Yacht Club boat, using Cox-Sprague scoring based upon fleet placement, with the combined scores from the Lloyd Trophy, Stratford Shoal Race and Katrina Cup.
- **11.6.** Each race is a qualifying race for North Sails' Huntington Bay Boat of the Year Trophy. Participation earns one point per race.
- **11.7.** Each race is a qualifier for the YRALIS PHRF Fall, Gitana, Sappho, Competitors, Kings Point, Mertz, and Youth Challenge trophies.

12. DISCLAIMER OF LIABILITY

12.1. Competitors participate in the regatta entirely at their own risk. See RRS rule 4, Decision to Race. The organizing authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.

13. INSURANCE

13.1. Each participating boat shall be insured with valid third-party liability insurance.

14. Other

14.1. Limited guest moorings will be available to boats at Centerport YC on a first come first served basis. Dry sail storage, hoist and launching ramp access may be available upon request.
