**SAILING INSTRUCTIONS:**

Sailing Instructions will be available at registration and they will contain diagrams of courses to be used.

**SCORING:**

Each class shall be scored using the low point system of Appendix A, except that no races shall be excluded. This changes RRS A2.1.

**PROTESTS:**

RRS 61.1 (A) IS CHANGED by ADDING THE FOLLOWING: "a Boat intending to file a protest shall additionally inform the race committee finishing line boat upon finishing or, if unable to finish, at the first reasonable opportunity, and shall include the sail number (s) or otherwise identify the boat(s) involved in the incident." Failure to do so will make the protest invalid.

**SAFETY:**

It is each competitor's exclusive and individual responsibility to decide whether or not to race or continue racing and to otherwise provide for his or her own personal safety. Competitors are reminded that all federal and state safety regulations should be observed.
