Notice of Race

Organizing Authority: Tahoe Yacht Club

1 RULES

- 1.1 This race will be governed by the rules as defined in *The Racing Rules of Sailing*.
- 1.2 Rule 40 is changed as follows: Competitors shall wear personal flotation devices, except briefly while changing or adjusting clothing or personal equipment. Wet suits or dry suits are not personal flotation devices. Flag Y may or may not be displayed.
- 1.3 Except when violating the restricted starting/finishing line Sailing Instruction, rule 44.1 will be changed as follows: A boat may take a One-Turn Penalty as described in rule 44.2 when she may have broken a rule of Part 2 while racing.
- 1.4 Special Procedures for Rule 42 applies (RRS Appendix P).
- 1.5 U.S. Prescriptions to RRS 63.2 and 63.4 are deleted.

3 ELIGIBILITY AND ENTRY

- 3.1 In accordance with RRS 75.1 boats must be entered by competitors who are members of appropriate sailing clubs. Those failing to comply are encouraged to join the Tahoe Yacht Club. Another alternative would be to join the Scuttlebutt Sailing Club at no charge:

- 3.2 This event is open to class-legal Lasers, Laser Radials, Laser 4.7s, and Laser Picos.
- 3.3 A minimum of four boats in a division are required in order to qualify for a start.
- 3.4 Rig swapping between Lasers and Laser Radials is NOT permitted. Competitors must select Laser Standard, Laser Radial, Laser 4.7, or Laser Pico at time of registration.
