

## NOTICE OF RACE

# 2020 SANTA CRUZ 27 NATIONALS SEPT 11TH-13TH, 2020

#### 1 RULES

- 1.1 The regatta will be governed by the rules as defined in The Racing Rules of Sailing (RRS).
- 1.2 RRS 40 will be changed to require competitors to wear a personal flotation device while racing, regardless whether the Y flag is displayed or not. The changes will appear in full in the sailing instructions. The sailing instructions may also change other racing rules.
- 1.3 For all classes, RRS 44.1 is changed so that the Two-Turns Penalty is replaced by the One-Turn Penalty.
- 1.4 The Santa Cruz 27 class will race under Santa Cruz 27 Class Constitution. <a href="http://www.sc27.org/documents">http://www.sc27.org/documents</a> SC27Constitution-September 2019.pdf

2.1 Boats may be required to display advertising chosen and supplied by the organizing authority. See ISAF Regulation 20


## 3 ELIGIBILITY AND ENTRY

- 3.1 The regatta is open to boats of the Santa Cruz 27 class. Santa Cruz 27 class rules will apply.
- 3.2 Santa Cruz 27 National Championship regattas are only open to boats deemed eligible by their respective class organizations that are fully paid and current members of the respective class organizations.
- 3.3 Eligible boats may enter by completing the online registration at <a href="http://www.scyc.org/racing.">http://www.scyc.org/racing.</a> Only online entries will be accepted.
- 3.4 Entries will be accepted up to 1800 hours on Wednesday, Sept 9, 2020.

#### 4 FEES

- 4.1 Entry Fee for the SC27 National Regatta is \$200.
- 4.2 Saturday taco dinner is included in the entry fee.
- 4.3 All entry fees are non-refundable unless the regatta is cancelled. If the regatta is cancelled, entry fees will be refunded less any non-refundable Regatta Network charges.

## 5 VENUE


- 5.1 The starting area will be located within a 1.5 to 2 mile radius of Walton Lighthouse located on the west jetty of the Santa Cruz Harbor.
- 5.2 The race area is defined by a four (4) mile semi-circle centered at the Walton Lighthouse. This area extends to Natural Bridges State Park to the northwest and Soquel to the southeast.

#### 6 COURSES

- 6.1 Inflatable marks will be used for windward-leeward courses. Inflatable and fixed marks can be used for the long distance race.
- 6.2 Long Distance Race Approx. 2 hrs. of sailing or 10 mile course


## 7 SCORING

- 7.1 Seven races are scheduled. 4 completed races constitutes a regatta.
- 7.2 If fewer than five races are completed, a boat's overall score shall be the total of all completed races.
- 7.3 If five or more races are completed, a boat's overall score shall be the total of all completed races excluding her worst score. This changes A2.1.

# 9 BERTHING/TRAILER STORAGE

- 9.1 Trailers are required to be parked in the trailer turn-around area adjacent to the bathrooms, or as directed by regatta volunteers.
- 9.2 Cars can park only in visitor parking spaces. Please do not risk a ticket so pay at parking pay stations before you leave your vehicle.
- 9.3 Boats will be assigned berthing within the Santa Cruz Harbor.

# 10 HAUL-OUT RESTRICTIONS

10.1 After the preparatory signal for the boat's first race, a boat shall not be hauled out except with and according to the terms of prior written permission of the race committee

# 11 INSURANCE

11.1 Participating boats shall be insured with valid third-party liability insurance. Boat owners are solely responsible to ensure that such coverage is current and adequate.
