NOTICE OF RACE

RULES

The regatta will be governed by the rules as defined in *The Racing Rules of Sailing* and the GYA Regulations for Sanctioned Events, "40 GYA WOMEN'S PHRF CHAMPIONSHIP."

ELIGIBILITY AND ENTRY

The regatta is open to all boats with a current Gulf Yacht Association PHRF certificate.

GYA Women's PHRF Championship: Skipper and crew shall be all female. Spinnaker Class only. See GYA Reg 40.4 for additional crew requirements.

This event will be sailed concurrent with the LPWSA Fleur de Lis Regatta (FDL). Boats that meet eligibility Requirements of both events may compete simultaneously in both the FDL and GYA Women's Championship. Separate registration is required for FDL. For FDL info see https://lpwsa.org/

FEES: The Entry Fee shall be \$35.00

SAILING INSTRUCTIONS

The sailing instructions will be the SYC General Sailing Instruction available online the SYC website.

VENUE: Races will be held on Lake Pontchartrain a mile or two north of Southern Yacht Club.

THE COURSES

The racecourses will be Windward Leeward type courses and one triangle fixed mark course.

SCORING: Two races constitute a series. There shall be no throw-outs.

PRIZES

Trophies will be awarded for 1st, 2nd, and 3rd place winning boats. Additionally, the 1st place boat shall receive the GYA Women's PHRF Championship perpetual trophy.
