



LNYC Coronavirus Phase 3 Reopening Protocol

General Club Operations while on the Grounds of LNYC

- Personal Protective Equipment (PPE) will not be supplied by the Club. It is recommended each member bring their own PPE - gloves, face masks, disinfectant wipes, and hand sanitizer - and use as recommended by CDC. Face Masks will be provided to Race Committee Members, if needed.

- Phase 3 opening will include:
 - All facilities at LNYC
 - Conditions for use:
 - Occupancy of restrooms should be limited to the 6' social distancing recommendations. Members should disinfect common areas before each use and are required to disinfect areas they have used while in the restroom.
 - The Club will provide disinfectant spray and disinfectant hand soap.
 - Restrooms will be cleaned and disinfected professionally every Monday and Friday, until November 9, 2020.

- It is recommended that the restrooms only be used when necessary; avoid use if possible.
 - Kitchen areas must be thoroughly cleaned after use.
 - Gatherings are limited to Executive order #169: 10 people indoors and 50 people outdoors.
 - Social Distancing and Face Mask rules are in effect.
- **General guidelines:**
 - Members and Guests are not permitted on club grounds if they are sick or are exposed to sick family members.
 - Use of the Club is voluntary for all purposes. No Member shall be required to be at the Club for any purpose.
 - If an individual has an underlying medical condition or is elderly, it is suggested Club use be avoided.
 - Each member will bring with them and take home all food items. Water bottles should be filled at home. Do not share personal items.
 - The Front Gate Keypad is a commonly touched item. It is recommended a glove or other item be used to open the gate.
 - Masks are now required in certain circumstances per Governor's Executive order 163. Please follow these guidelines.
 - 6' social distancing is recommended while at the Club. If requested by another member you must keep the 6' distance.
 - Groups of 10 or more in any one inside area are forbidden.
 - Groups of 50 or more in any one outside area are forbidden.
 - Frequent hand washing is a good defense to avoid Covid-19.
 - Members observed not following these guidelines will be asked to leave the Club Grounds.

Race Committee / RC Boat and Club owned Boats Use Policy – SARS-CoV-2 Limited Use Period

The purpose of this document is to help define the acceptable use of LNYC owned Race Committee Boats and Sailboats. This applies to all boats in the fleet and is in effect until further notice.

- Members should clean the needed surfaces on the boat before and after use (following CDC Cleaning and Disinfecting Guidelines).
- Only members using the boat for a given day may help launch the boat. Do not exchange boats or people with out disinfecting the boats and equipment.

- Members using LNYC owned boats with non-family members must sign the LNYC Covid - 19 Notice and Liability Release. The PRO will collect and save these documents.
- While on the dock and loading equipment, members should practice social distancing and wear masks as recommended by the CDC.
- Members should bring their own life jackets and may not use the shared life jackets.
- Members should wear personal protective equipment as needed.

- Race Committee Equipment:
 - Use only what is absolutely needed
 - Each item must be disinfected after each use with a disinfectant spray provided by the Club.
 - Do not help one another with dock lines unless necessary.
 - Do not handle equipment for anyone else's boat.

Club Sanctioned Sailing Events:

- The Board has agreed to move ahead with the Scheduled LNYC Sponsored Sailing Events this Summer and Fall. Under these conditions:
 - Regatta Network must be used for registrations and notices.
 - The guidelines in this document must be followed.
 - All participants must sign Covid-19 Notice and Liability Release.
 - LNYC will not sponsor social events such as dinners, cocktail hours, other gatherings, etcetera.
 - Registrations, Notice of Races, Sailing Instructions, and the Official Notice Board will be online only. All these documents can be found on Regatta Network.
 - Skippers meetings and Awards Ceremonies may be held outside subject to social distancing and number of persons guidelines. All information is available online and no one is required to attend.

- Due to limited Race Committee and most likely inexperienced help, rescue is something we need not be doing. LNYC events will be cancelled in heavy air at the Discretion of the PRO based on Race Committee skills and availability.
