NOTICE OF RACE (revised 9/28/20)

1 Rules

1.1 The regatta will be governed by the rules as defined in *The Racing Rules of Sailing* (RRS).

1.2 Racing Rule 40 is changed as follows: Replace the entire Rule with, "Competitors shall wear personal flotation devices, except briefly while changing or adjusting clothing or personal equipment. This rule applies at all times while afloat. Wet suits and dry suits are not personal flotation devices. Flag Y need not be displayed."

1.3 The regatta will be sailed in Radial rigged Lasers. "Practice" sails are permitted.

1.4 Competitors must not have reached their **19th** birthday by October 10, 2020.

1.5 If there are sufficient entries, the regatta will be sailed in two divisions, Gold and Silver. Division allocations will be done by MPYC. The two divisions shall have separate starts and be scored separately.

1.6 The organizing authority is the Monterey Peninsula Yacht Club.

2 Eligibility and Entry

2.1 Competitors will be required to agree to a waiver of liability as a condition of eligibility. This waiver must be completed either during online registration or at the event check-in. Parents/Guardians of minors must sign the waiver form.

3 Risk

It is the competitor's decision to enter the regatta and to start or continue any race. The competitors are ultimately responsible for the risks. The competitor will accept full responsibility for all his/her actions during any activity related to the event. This includes on-shore activities before, during, and after the regatta.

10:30 Competitor Meeting on MPYC deck and dock

12:00 First warning signal, races to follow

1:30 On-the-water lunch break (see further information below)

2:00 Racing continues

6 Fees

6.1 Required Fee; \$25 payable at registration on Regatta Network

6.2 Entries will not be accepted after 10:30 am on October 10, 2020.

7 Parking

Paid parking is available on Monterey Municipal Wharf #2. Trailer parking is available near launch ramp.

8 Sailing Instructions

The sailing instructions will be available during on-site registration and on Regatta Network.

9 Courses & Racing Area

9.1 Courses will be standard windward/leeward courses as described in the sailing instructions.

9.2 The racing area will be north of the MPYC yacht club about a mile out to sea.

10 Scoring

10.1 The Low Point Scoring System, Appendix A4, will be used except as modified below.

10.2 A minimum of 1 race must be completed to constitute a regatta.

10.3 When 6 or more races are completed a sailor may discard their worst score.

11 Trophies

11.1 Trophies will be awarded for the top three finishers for Gold and Silver divisions, or for the top three finishers overall if there is only one division.

11.2 The top MPYC member finisher in the Gold division (or overall if only one division) will be awarded the **MPYC Junior Club Champion** for 2020 and awarded the Harvey Kilpatrick perpetual trophy (see photo).

12 Further Information

Social distancing and face coverings are required while on land.

A Covid waiver is required (see Regatta Network).

A parental release and medical waiver is required (see Regatta Network).

Trailer storage available starting noon Friday October 9th until 9:00 PM Saturday at the MPYC dry storage yard.
