The following section(s) of The Notice of Race is amended as follows:

11. **CLASSES:** Classes shall be Cruiser, Multi-Cruiser, Pocket Cruiser and Racer/Cruiser as defined by WFPHRF. The use of free-flying headsails in any cruising class is permitted, however, for the sole purposes of division assignment, such sails shall be considered spinnakers.

11a. **RATINGS:** A boat's rating shall remain in effect for the duration of the series and can only be modified by the organizing authority or WFPHRF. For example, a registered spinnaker boat that opts to not fly her spinnaker shall not be allowed to use her non-spinnaker rating.

16. **BERTHING:** Complimentary dock space at the Venice Yacht Club (VYC) shall be made available to entrants on a first-reserved, first-served basis and must abide by all marina rules and regulations established by VYC. Reservations shall be made with the VYC dockmaster. Additionally, while on the property, all yacht owners and crew shall abide by the rules and regulations of VYC. Additional berthing may be available at Higel Park, adjacent to VYC.

Competitors shall be responsible for damage or injury caused by their breach of The Racing Rules of Sailing or applicable governmental rules for the avoidance of collision. I agree that my crew and my guests are my responsibility and we will abide by the rules and regulations of the Venice Yacht Club. I further agree to be bound by the Racing Rules of Sailing and by other rules that govern this event. I agree that the West Florida PHRF Rating Certificate filed with this entry is a true copy of my valid Rating Certificate and that no changes have been made to my yacht that would affect her rating.
