ASSUMPTION OF RISK RELEASE OF LIABILITY, WAIVER OF CLAIMS, AND COVENANT NOT TO SUE RELATING TO CORONAVIRUS/COVID-19

The signed consent form MUST be on file for competitors in order to complete registration. One must be on file for EACH sailor and support person.

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization, the Center for Disease Control, and other agencies, governments, and individuals. COVID-19 is extremely contagious and is believed to spread mainly from person-to person contact. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited the congregation of groups of people. The Alamitos Bay Yacht Club (“the Club”) has put in place certain preventative measures to reduce the spread of COVID-19; however, the Club cannot guarantee that you or your child(ren) will not become infected with COVID-19. Participating in racing and related activities could increase your risk and your child(ren)’s risk of contracting COVID-19. Accordingly, the Club is requiring the execution of this Release, Waiver, and Covenant as an absolute condition precedent to participate in racing or related social activities sponsored by the Club.

For purposes of this release, waiver, and covenant, you must assume that whatever being done to protect you will not be sufficient. If you are not willing to assume the risk, release all claims, and promise not to sue, you are not permitted to participate in Club race and Club race related activities.

By signing (manually or electronically) this agreement, I

1. **acknowledge the contagious nature of COVID-19 and voluntarily assume the risk** that my child(ren) and I may be exposed to or infected by COVID-19 by participating in Alamitos Bay Yacht Club races and Club sponsored activities, and that such exposure or infection may result in personal injury, illness, permanent disability, and death. I understand that the risk of becoming exposed to or infected by COVID-19 may result from the actions, omissions, negligence, gross negligence, willfulness or intentional acts of myself and others, including, but not limited to, Club employees, volunteers, and Club sponsored activity participants and their families.
2. **voluntarily agree to assume all of the foregoing risks and accept sole responsibility** for any injury to my child(ren) or myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I or my child(ren) may experience or incur in connection with my child(ren) and my participation in Alamitos Bay Yacht Club races or race related activities (“Claims”).
3. **on my behalf, and on behalf of my children, hereby release, covenant not to sue, discharge, and hold harmless** the Club, its employees, agents, and representatives, of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto that I or my child(ren) might experience in connection with our attendance or participation in Club sponsored activities. I understand and agree that this release, covenant not to sue, and hold harmless includes any Claims based on the actions, omissions, negligence, gross negligence, willfulness, and intentional acts of the Club, its employees, agents, and representatives, whether a COVID-19 infection occurs before, during, or after participation in any Club sponsored activity.
4. **hereby certify** that my child(ren) and I are covered by health insurance.

I understand that I have no factual or legal basis to bring any action against the Club, its board of directors, officers, general manager, employees, members, volunteers of the Club, fellow members and non-members who may have been present or involved in any way.
