NOTICE OF RACE

- **1.0 Rules.** The regattas will be governed by The Racing Rules of Sailing 2021-2025 (RRS), the prescriptions of US SAILING, this Notice of Race and the Sailing Instructions, rules of the J-24 Class Association, and he rules of the 110 Class Association (except as altered by this Notice of Race and the Sailing Instructions).
- 2.0 Eligibility. Boats of the following classes are eligible to enter:

Ron Gibbons Memorial, Whaleback, Lobster Regatta, Singlehanded Regatta and Dave Mowers Memorial Regatta:

- PHRF Racing, 2021 PHRF-NE certificate required.
- PHRF Cruising, non-spinnaker, 2021 PHRF-NE certificate preferred. A boat without a valid certificate will be assigned a provisional handicap using the base PHRF-NE ratings and appropriate adjustment as determined by the committee.
- Ron Gibbons Memorial Regatta will include a one design J-24 class.
- Lobster Regatta and Singlehanded Regatta will include a Junior Class.
- Singlehanded Regatta will have a Laser Class.
- Any mono-hull boat that has a valid 2021 PHRF-NE rating or for which the race committee can determine a provisional handicap using the base PHRF-NE ratings and appropriate adjustments. Skippers without valid 2021 PHRF-NE ratings are encouraged to fill out a rating form and submit it to the race committee as soon as possible. - **2.1** Safety. All boats are required to meet minimum government regulation for safety equipment and comply with the Offshore Racing Council rules for category IV. The race committee reserves the right to inspect any boat for required equipment and may disqualify boats found not in compliance.

- **4.0** Fee. There is one time entry fee of \$100.00 to participate in this regatta series. For entry for 2 races the fee is \$60.00 and \$40.00 for entry into one race. The fee for participation in the social events following the regattas are as follows:

5.0 Race Format and Schedule.

- Warning for first class scheduled at 11:55 AM.
- One Ocean is race planned for the PHRF racing & cruising fleet.
- Around the buoy races are at the discretion of the race committee
- Single Handed Challenge will have one race
- If in any race 4 or more one design class of boats report to the line they will have their own start.
- Final class and divisions will be set once number of participants is known. The race committee reserves the right to assign class breaks or to condense classes. A single race will be sufficient to constitute the regatta for any of the events.

6.0 Scoring.

Results of the regatta will be based on the low point scoring system with two (2) throw out races. The PHRF yachts results will be handicapped using the time on time system.

• Mowers Memorial Regatta will be a pursuit format.

7.0 Social Schedule.

8.0 Trophies:

Prizes will be awarded for yachts finishing 1st, 2nd and 3rd in each class.

9.0 Skippers Meeting:

As skippers meeting, which will include coffee and breakfast pastries, will be held at the Kittery Point Yacht Club or the Portsmouth Yacht Club (Dave Mowers Regatta) on the morning of the race at 09:30 Race details as to course and race structure will be announced at that time and all coordinates handed out. Information will be posted on the RC Boat if the skipper is unable to attend, however attendance is strongly suggested.
