NOTICE OF RACE

1. **RULES** This regatta will be governed by the *rules* as defined in *The Racing Rules of Sailing (RRS) for 2021-2024*.
2. **ELIGIBILITY AND ENTRY**
 - 2.1 The event is open to the Flying Scot class only. FSSA membership is not required, but is recommended.
 - 2.2 Eligible competitors may enter the regatta by submitting an entry form and fee online at Regatta Network.
3. **REGISTRATION/FEES**

 - 3.2 Entry fee per boat: \$55. No dinner will be provided due to Covid-19 restrictions.
4. **SCHEDULE OF EVENTS** A maximum of 5 races may be held.

Saturday - May 15, 2021
1100 Skipper's Meeting
1200 Warning Signal for first race (other races to follow)
Sunday - May 16, 2021
1000 Warning Signal for first race (other races to follow)
1300 Last possible Warning Signal for the day
5. **SAILING INSTRUCTIONS**

Sailing instructions to include the courses to be raced will be available at the Skipper's Meeting and a copy posted on the Official Race Notice board.
6. **THE COURSE**
 - 6.1 The racing area will be just off the Upper Keys Sailing Club on Buttonwood Sound, Key Largo, Florida.
 - 6.2 Courses will be windward-leeward as described in the sailing instructions.
7. **SCORING**
 - 7.1 The Low Point Scoring System in Appendix A of the Racing Rules of Sailing will be used. Five races are scheduled in which completion of one race constitutes a Regatta.
 - 7.2 When six or more races have been completed, each boat's score shall be the total of all her scores with the worst score being excluded.
8. **PRIZES**

Awards for the top three competitors will be presented after the last race on Sunday, May 16, 2021.
