- 1. INVITATION--Percy Priest Yacht Club cordially invites you and your crew to attend the Galen Freeman One Design Regatta May 15 & 16, 2021.
- 2. SITE--The regatta will be held on J. Percy Priest Lake in Nashville, Tennessee. Land based activities will be held at Hamilton Creek Sailboat Marina.
- 3. RULES--
 - 3.1. The COVID-19 Policies posted on www.PPYC.org website shall be adhered to by all participants.
 - **3.2.** The regatta will be governed by the *rules* as defined in *The Racing Rules of Sailing* (RRS).

4. 4. ELIGIBILITY AND ENTRY

- **4.1.** The regatta will be open to International J/22 Class Yachts registered with PPYC for this Regatta.
- **4.2.** All registrations must be done online from <u>WWW.ppyc.org</u> including payment of regatta fees. There will be no registration nor payment methods at the regatta site.
- **4.3.** A Waiver and Release of Liability and Emergency Contact form signed by the owner/skipper and each crew member must be placed in the container labeled "PPYC WAIVERS". Box(s) (1 or 2) will be located on the deck and/or between the building and the bathrooms depending on weather conditions. No boat will be fully registered nor scored without submitting this completed form. In the event of a crew member substitution during the regatta, the new crew member must submit a signed waiver of liability to the Regatta Committee prior to racing for that boat's entry to remain valid. Waiver forms can be printed from the Race Documents found on www.PPYC.org.
- **5. FEES**-- The regatta entry fees are as follows:

6. SCHEDULE

0800	All registrations are now required online via the PPYC web site, by 0800.	
0900	Place Waiver and Release & Emergency Contact Information form into the designated box (located on the deck or near the bathrooms depending on weather conditions). Waivers are required by 0900. If incomplete, the boat will not be scored.	
1000	Skippers' Meeting will be conducted on VHF channel 68.	
1100	Warning Signal for Race, Subsequent races may follow.	
After Race	After the racing, there are no scheduled social plans. Attendees are asked to adhere to the City marina policy that all alcoholic beverages must be contained in a "red cup" (red solo cups will be widely available).	
Sunday, May 16, 2021		
1000	Warning Signal. Subsequent races may follow.	
1300	No race will be started after this time.	
Awards	Awards presentation will be as soon as possible after last race. If it is raining, the trophy presentations will be on the building deck. ONE REPRESENTATIVE MAY ATTEND PER BOAT TO SATISFY GOVERNMENT RESTRICTIONS. If it is not raining, presentations will be in the East-most paved parking lot. The attendance limit is 25 persons.	

7. SAILING INSTRUCTIONS

- **7.1.** This Notice of Race (NOR), the **Sailing Instructions** (SI) and any changes or amendments will be dated and posted online at **WWW.PPYC.ORG.** Click on the "**Galen Freeman One Design Regatta**" in the "Upcoming Events" list.
- **7.2.** The SI dated no later than the Tuesday before the regatta will be the final SI posted online. That SI may be modified only by posts on the regatta bulletin board. To promote social distancing, a copy of amendments to the SI and/or other notices will be taped to the window pane on the deck side of the marina building.

8. COURSES

- **8.1.** The regatta will consist of as many as **7 buoy course races** as described in **Attachment A** of the Sis.
- 8.2. Races will start within three miles of the entrance to the Hamilton Creek Sailboat Marina cove.
- **8.3.** Course descriptions and diagrams will be posted on the official notice board or attached to the Sailing Instructions as an addendum.
- **8.4.** Actual courses and course length will be determined by the Race Committee based on the sailing conditions.
- **9. LAUNCHING, DOCKING AND HAULING--**Launching, docking and hauling may be done at Hamilton Creek Sailboat Marina free of charge. A ramp is available for trailer launching. No boat hoist is available.

10. RADIO COMMUNICATIONS, COURTESY BROADCASTS & RECALLS

- **10.1.** All boats are strongly encouraged to carry a VHF radio and monitor it during the regatta.
- **10.2.** The race committee may make periodic courtesy broadcasts by VHF radio on Channel 68. Information reported is provided as a courtesy to the competitors and does not in any way alter the competitor's responsibility to observe the race committee's visual signals. Errors or omissions during these courtesy broadcasts will not be grounds for requesting redress. This changes RRS 62.1(a).
- 10.3. When an individual recall is signaled, the race committee may at its discretion attempt to hail the sail numbers of the recalled boats. The hail may be by VHF radio on Channel 68, or by loud hailer or bullhorn. Such a hail is a courtesy hail only. Failure of the race committee to hail, failure of a boat to hear the hail for any reason, or the method, order or timing of the hail will not relieve the boat of its obligation to start correctly and will not be grounds for requesting redress. This changes RRS 29.1 and 62.1(a).
- 11. PRIZES --- EACH J/22 ONE DESIGN CLASS sailboat Registered and participating in the GFOD Regatta will receive a Trophy.
- 12. DISCLAIMER OF LIABILITY AND WAIVER--Competitors participate in the regatta entirely at their own risk. See RRS 4, Decision to Race. Percy Priest Yacht Club will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta. Competitors agree that the race organizers (organizing authority, race committee, protest committee, host club, sponsors, or any other organization or official) will not be responsible for damage to any boat or other property or the injury to any competitor, including death, sustained as a result of participation in this event. As an inducement to the race organizers to produce the regatta, each competitor agrees that by participating in this event each competitor is deemed to have waived all claims against and released the race organizers from any and all liability associated with such competitor's participation in this event to the fullest extent permitted by law and is deemed to have warranted that he has obtained this same release of the race organizers by each crew member.
- 13. INSURANCE--Each participating boat shall be insured by its owner with valid third-party liability insurance.
