



Cat Harbor Layover – June 12, 2021

Sailing Instructions

(Amended 6/3/2021)

1. RULES

Competitors shall comply with DRYC's current Schultz's Landing Cat Harbor Facility COVID-19 Protocols. The Protocols may be updated weekly and will be posted as a Notice to Competitors.

2. CHANGES TO SAILING INSTRUCTIONS

Any changes to the Sailing Instructions (SIs) will be posted at dryc.org by 0830 June 12th.

3. COMMUNICATION WITH COMPETITORS

On the water, the Race Committee (RC) may make oral changes and broadcast on VHF channel 68.

4. SCHEDULE

4.1 The first warning signal is scheduled for **1055**.

4.2 Before the first warning signal and while the L flag is flying, all entries shall pass the stern of the RC boat and check in. Other than out of the area entries, **no radio check-ins** are allowed. Boats not checking in may be scored DNC without a hearing. [DP] This changes Rule 63.1, A4 and A5.

5. COURSES

From the starting line sail the course signaled by the RC (code flag A or B):

Course A (36.5 nm) – Leave the El Segundo buoy (2ES) and the west end of Catalina Island to port. Proceed to **SI 7**.

Course B (29.2 nm) Leave the El Segundo buoy (2ES) to port. Proceed to **SI 7**.

6. THE START

6.1 The starting area will be in the vicinity of MdR H Mark (see MdR Course Chart 17)

6.2 The starting line will be between an orange inflatable mark and an orange flag on the RC boat.

6.3 Multiple sound signals will be made approximately one (1) minute before the first warning signal.

7. THE FINISH

7.1 **PHRF Division:** The finishing line will be between the Coast Guard mooring buoy (white with blue band) to port and an orange flag on RC boat to starboard. If the RC boat is not on station, a mark will take her place. Record your finish time when you cross the finishing line.

7.2 **Cruising Division:** The finishing line begins at the Catalina Island west end light and extends 1/2nm to seaward. Record your finish time when the light bears 90° magnetic from your bow.

7.3 All boats shall complete and email a photograph of the Race Report Form (Addendum 1) to the Event Chairman (see **SI 12**) within 30 minutes of finishing or retiring. A boat's sail number and finish time shall be in the email subject line. Boats not complying may be scored DNF without a hearing. [DP] This changes Rule 63.1, A4 and A5.

7.4 All boats shall deliver a hard copy of the Race Report Form to the RC at Schultz's Landing (raised deck area near galley) as soon as possible after finishing. [DP]

8 TIME LIMIT

A boat not finishing by 2230 (Time Limit) will be scored DNF, this changes RRS 35.

9 HEARING REQUESTS

The protest time limit is 60 minutes after a boat finishes. A boat shall inform the RC of her intent to protest on the Race Report Form (Addendum 1). Protest hearings will be scheduled for a later date.

10 SAFETY REGULATIONS

A boat that retires shall promptly notify the RC at the first reasonable opportunity. Use VHF or if unable to receive an acknowledgment, contact the finish PRO listed in **SI 12**.

11 RISK STATEMENT

Competitors participate in this race entirely at their own risk (see RRS 3). By participating in these races, each competitor and crew agrees to release the race organizers (organizing authority, host yacht club, race committee, protest committee, sponsors and any others acting in any official capacity for these races) from any and all liability associated with such competitor's participation in this event, to the fullest extent permitted by law.
