**PROTESTS:**

RRS 61.1 (A) IS CHANGED by ADDING THE FOLLOWING: "A Boat intending to file a protest shall additionally inform the race committee finishing line boat upon finishing or, if unable to finish, at the first reasonable opportunity, and shall include the sail number (s) or otherwise identify the boat(s) involved in the incident." Failure to do so will make the protest invalid.

**SAFETY:**

Competitors are reminded that all federal and state safety regulations should be observed. Competitors participate in the regatta entirely at their own risk. See RRS 4, Decision to Race. Neither the Organizing Authority, nor the host club, nor the race officials, shall accept any liability for material damage or personal injury or death sustained in conjunction with, prior to, during, or after the regatta.
