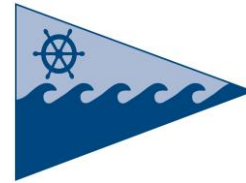

1. RULES

1.1 This regatta will be governed by the *rules* as defined in “*The Racing Rules of Sailing for 2017-2020*”

2. ELIGIBILITY AND ENTRY

2.1. Eligible boats and drivers need to enter by completing an online entry form on the Regatta Network website:

2.2. There will be at least two classes, cruising and performance class. Classes may be added depending on participants. Race committee may combine or segregate classes at their discretion

2.3. The entry fee is \$20. Entries are due by 10:00 HRS on the day of the race

3. SCHEDULE

3.1 Performance: One random-leg race scheduled. The first warning is scheduled for 11:55 hours.

3.2 Cruising: One random-leg race is scheduled. The first warning is scheduled after the Performance start.

4. SAILING INSTRUCTIONS AND SKIPPERS MEETING

4.1 The Sailing Instructions and classes will be posted on www.RegattaNetwork.com website, by 19:00 hours, the night before the race.

4.2 Skipper’s meeting will be at PMYC at 09:00 hours the day of the race.

5. COURSES

5.1 Course will be random leg using ASMBYC Marina del Rey Course Chart 17

5.2 The starting area will be in the vicinity of SS Mark

6. SCORING

6.1. Scoring will be based on Time on Distance ratings using the Random Leg Course Rating (RLC)

6.2. PHRF SoCal Corinthian race adjustments accepted

7. HOSPITALITY

Post-race hospitality and trophy presentation will be held at Pacific Mariners Yacht Club: 13915 Panay Way, Marina del Rey, CA.

8. TROPHIES

Trophies will be presented to the winners of their respective classes: The Heather Perkoff Perpetual Trophy will be awarded to the winner in the Cruising class.
