## Notice of Race

<u>**Rules:**</u> This regatta will be governed by the current Racing Rules of Sailing, the Sailing Instructions on Seal Beach Yacht Club Course Chart **Random Leg 2021** and this Notice of Race. Double jibs/genoas for non-spinnaker classes and non-spinnaker yachts sailing in spinnaker classes are allowed.

**Eligibility:** This regatta is open to members of SCYA recognized Yacht Clubs and Sailing Associations, and to any One Design Fleet which establishes a class. **YACHTS RACING IN PHRF MUST HAVE A CURRENT PHRF RATING.** The following classes are invited to participate: PHRF - Spinnaker and Non-Spinnaker, and any One Design Fleet. Four (4) or more entries may establish a One Design class. Changing PHRF class after first day of racing is not allowed. If a rating change occurs, the new rating will be used for subsequent races and the boat will remain in the original class. PHRF <u>AREA C RANDOM LEG</u> **COURSE RATINGS** WILL BE USED.

**Entries:** Entries may be on the form below and must be accompanied by a check for the amount of the entry fee made payable to Seal Beach Yacht Club or you may enter online at: <u>http://www.regattanetwork.com/event/23316.</u> Paper entries may be mailed to RACE CHAIRMAN, Seal Beach Yacht Club, 255 Marina Drive, Long Beach, CA 90803 or placed in the Race Entry Box at the Seal Beach Yacht Club. Classes and PHRF class breaks will be established from entries received by 1800 November 5, 2021. Late entries for established classes will be accepted at the Club up to 0800 on November 7, 2021.

**Entry Fee:** Entries must be accompanied by a check made payable to Seal Beach Yacht Club. Series entry fee will be \$45.00 if submitted by November 4, 2021 and \$60.00 if submitted after that date. Individual race fees will be \$20.00 if submitted by Thursday prior to the race and \$30.00 thereafter.

**Starting Order:** Established classes, starting order, and PHRF class breaks will be posted at the Club by 1800, November 5, 2021. First warning will be 1255 each day. This series will be a total of 3 races with **no throw out**.

Sailing Instructions and Courses: See Seal Beach Yacht Club Course Chart Random Leg 2021.

**Protests:** As prescribed in the Sailing Instructions.

<u>**Time Limit:**</u> Each race shall be called at 1630. However, a yacht finishing prior to 1630 shall establish the race for that class and the Race Committee shall remain on station and finish only established classes for the next 30 minutes. **No yacht shall be finished after 1700.** 

**Trophies:** Trophies will be presented at Seal Beach Yacht Club on December 6, 2020 as soon as possible after completion of that day's races, unless otherwise announced. The number of series trophies will be based on the number of yachts entered in each class by 1800, November 5, 2021: 1- 4 boats (1 trophy); 6-9 boats (2); 10-15 boats (3); 16 or more boats (4). Trophies not claimed within 30 days shall remain the property of Seal Beach YC.

WAIVER, RELEASE AND INDEMNIFICATION: To the fullest extent permitted by law, I waive all claims, forever release and agree to indemnify and hold harmless Seal Beach Yacht Club (SIBYC), its owners, affiliates, officers, directors, members, employees, agents, committee persons, and race officials, acting in their official capacities, both jointly and severally from any and all damages, injury, liability, loss, coast or expense, including attorney fees, to any persons and/or property arising from y or my crew's actions and/or participation in the race, including SIBYC's active or passive regular negligence, but not willful misconduct or gross negligence.

7. ASSISTANCE: Any assistance provided by SIBYC race committee vessels and personnel will be at the risk of the participants.
