SAILING INSTRUCTIONS

1. RULES

The regatta will be governed by the rules as defined in the current Racing Rules of Sailing.

2. ELIGIBILITY AND ENTRY

Regatta is open to boats of the Finn Class.

3. NOTICES TO COMPETITORS

Notices to competitors will be posted on the official regatta notice board, which is the bulletin board next to the office door inside the Upper Keys Sailing Club.

4. CHANGES IN SAILING INSTRUCTIONS

Any change in the sailing instructions will be posted before 0800 on the day it will take effect.

5. SIGNALS MADE ASHORE

Signals made ashore will be displayed from the flagpole at the UKSC.

6. SCHEDULE

6.1 Competitors' Meeting is scheduled for 1200 on January 29.

6.2 Number of races per day:

The Race Committee will attempt to get in up to 3 races per day but not more than 5.

6.3 Scheduled time of the first warning signal:

January 29	1300
January 30	1100

On the last day of the regatta no warning signal for a race will be made after 1400 hours.

7. CLASS FLAG

All Classes will start together with a solid red flag.

8. RACING AREA (see NOAA Chart 11464)

Buttonwood Sound, on the western side of Key Largo, Florida east of the intercoastal waterway.

9. THE COURSE

Course 1 will be a windward-leeward course with offset windward mark and leeward gate marks. The start will be upwind. All Finns will go around the course once. (S-A-F)).

Course 2 will be a windward-leeward course with offset windward mark and leeward gate marks. The start will be upwind and finish downwind, 2 laps (S-A-G-A-F)

10. MARKS

Marks for the course will be yellow or orange inflatable marks.

11. THE START

11.1 Races will be started by using rule 26.

11.2 The starting and finishing line will be between a staff displaying an orange flag on the race committee boat at the starboard end and a mark at the port end.

12. PENALTY SYSTEM

Rule 44.1 is changed by substituting the One-Turn Penalty for the Two-Turns Penalty.

12. PROTESTS AND REQUESTS FOR REDRESS

12.1 In addition to the requirements of RRS 61.1(a), protesting boats are requested to inform the race committee of their intent to file a protest as soon as possible after finishing and display a red flag.

12.2 Protest forms are available at the UKSC Office. Protests shall be delivered there within the protest time limit.

12.3 The protest time limit is 30 minutes after the RC boat has docked.

12.4 Notices of protests by the race committee or protest committee will be posted to inform boats under rule 61.1(b).

13. SCORING

13.1 When fewer than five races have been completed, a boat's score will be the total of all scores. When five or more scores have been completed, a boat's series score will be the total of its race scores excluding its worst excludable score.

13.2 Nine races are planned of which one race must be completed to constitute a series.
The low point system of Appendix A will apply.

14. PRIZES

Prizes will be awarded to the first through third place finishers.

15. DISCLAIMER OF LIABILITY

Competitors participate in the regatta entirely at their own risk. See rule 4, Decision to Race. The organizing authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.

16. ENVIRONMENTAL CONCERNS

Competitors in all UKSC events are prohibited from discharging any refuse overboard, including but not limited to cans, bottles, and plastic. This action is protestable either by any competitor or by the Race Committee.
