

RESCHEDULED SAILING INSTRUCTIONS

## 1. RULES

- **2.1.** The regatta will be governed by the rules as defined in:
  - 1.1.1. The Racing Rules of Sailing (RRS).
  - 1.1.2. The current PHRF regulations, as administered by YRA of Long Island Sound (YRALIS) including non-spinnaker regulations.
  - **1.1.3.** US SAFETY EQUIPMENT REQUIREMENTS (SER), Nearshore Category.
  - 1.1.4. Current class rules for One-Design fleets. J/80 class rule C.4 and J/105 class rule 7.1 regarding weight limits are waived in One-Design divisions.
  - 1.1.5. RRS Appendix V1 and V2.
  - 1.1.6. The RRS will be changed as noted in these instructions.

#### 3. ELIGIBILITY AND ENTRY

- **3.1.** The regatta is open to boats of PHRF classes whose owner is a member in good standing of the LHYC.
- **3.2.** Entry is done using the Lloyd Harbor Yacht Club's online registration at www.lhyc.org, following the link to the Race Information page. The final deadline for entries is 1800 hours, August 11.
- **3.3.** There will be two divisions, Cruising and Racing. Boats which generally do not race and use "cruising canvas" will race in the cruising division. All other boats will race in the Racing Class.
- **3.4.** Entrants must possess a valid YRALIS PHRF certificate, a valid One-Design certificate, or receive a waiver and LHYC handicap rating from the LHYC Measurer.
- **3.5.** This is a Non-Spinnaker event. No spinnakers of any variety may be used.

## 4. NOTICES TO COMPETITORS

4.1. Notices to competitors will be posted on the LHYC web site (http://www.lhyc.org/) by 1800 on the day prior to the event, and shall be broadcast on VHF channel 72 prior to the first warning signal.

#### 5. CHANGES TO SAILING INSTRUCTIONS

**5.1.** Any change to the sailing instructions will be posted before 1800 hours on the day prior to when it will take effect and announced prior to the first warning signal on VHF channel 72.

#### 6. SIGNALS MADE ASHORE

**6.1.** No signals will be made ashore.

# 7. SCHEDULE OF RACES

- **7.1.** Racing is scheduled for August 13, 2022.
- **7.2.** The scheduled time for the first warning signal is 1400 hours.

## 8. CLASS FLAGS

- **8.1.** There will be two divisions, Racing (Class 1) and Cruising (Class 2). Boats which generally do not race and use "cruising canvas" will race in the cruising division. All other boats will race in the Racing Class.
- **8.2.** All boats shall identify themselves to the RC by sailing past the stern of the signal boat on starboard tack with mainsail hoisted prior to the first warning signal.

## 9. RACING AREAS

9.1. Rendezvous will be made in the vicinity of Nun "2" at the entrance to Lloyd Harbor

#### 10. COURSES

**10.1.** Courses will be signalled by the RC using a letter placard indicating the course.

or 13 (to be announced on water)



- **10.1.1. Course A**: Bell "11B", Leave to port, and back. 10.8 nm.
- **10.1.2.** Course B: Flasher "1" (Sand City) to port, Bell "8" Target Rock to port, then finish. Boats may sail clockwise or counter clockwise at their discretion but are reminded to follow right of way rules when rounding marks. 3.4 nm.
- **10.1.3. Course C**: Using Course B (above) using Nun "2" off Lloyd Harbor as the turning mark to begin the second lap of the course, 6.8 nm boats must complete both course rotations in the same direction.

## **11. MARKS**

**11.1.** The starting and finishing mark will be Nun "2" off Lloyd Harbor.

#### 12. THE START

- **12.1.** Races will be started according to RRS 26 using a rolling sequence where the Start of one division is the Warning Signal for the following division unless otherwise announced by the RC.
- 12.2. The starting line will be between an orange flag on the signal boat and Nun "2"
- 12.3. The RC will attempt to identify OCS boats and broadcast their sail numbers via VHF channel 72. Failure of a boat to see or hear her recall notification and the timing and order of such hail shall not be cause for redress. This changes RRS 62.1a.
- **12.4.** Boats whose warning signal has not been made shall stay clear of the starting area and boats in their starting sequence.
- **12.5.** Any boat starting later than ten minutes after her starting signal will be scored Did Not Start without a hearing. This changes RRS A5.
- **12.6.** If the automated starting system is used, i.e., the Ollie System, racers should be aware of the short, repetitive sounds emitted prior to the initial warning signal and not consider them part of the starting sequence.

#### 13. CHANGE OF COURSE

**13.1.** Courses will not be changed after the first start signal, but may be shortened.

#### 14. THE FINISH

**14.1.** The finishing line will be between a staff displaying a blue flag on the signal boat and Nun "2" unless the course

is shortened in accordance with RRS 32.2.

## 15. TIME LIMIT

**15.1.** The time limit will be 17:15 hours for all boats. Any boat not finishing by the time limit will be scored Did Not

Finish without a hearing. This changes RRS rules 35, 63.1, and Appendix A.

#### 16. PENALTY SYSTEM

16.1. Penalties at the Time of the Incident

The One-Turn Penalty as described in RRS V1 is in effect. This modifies RRS 44.1.

16.2. Post-Race Penalties

The Post-Race Penalty as defined in RRS V2 may be taken prior to the opening of a protest hearing.

## 17. PROTESTS AND REQUESTS FOR REDRESS

- **17.1.** A boat initiating a protest shall immediately after finishing, notify the race committee over VHF channel 72 of its intent to lodge a protest and the identity of the boat(s) being protested until acknowledged by the race committee. This changes RRS 61.1(a).
- 17.2. Notice of Protest(s) by the RC will be made via VHF channel 72 to inform boats under RRS 61.1(b).
- 17.3. Protests shall be written on US Sailing protest forms or equivalent and shall be delivered to the Protest Committee Chairman as described in "Contacts", Section 23.2. Protests shall be delivered in person or via email to protest@lhyc.org by 2200 hours on the day following the event. The same time limit applies to protests by the RC about incidents they observe in their racing area and for requests for redress. This changes RRS 61.3 and 62.2
- **17.4.** Protest hearings will be scheduled accordingly, and posted on the event website notice board to inform competitors of hearings in which they are parties or named as witnesses.

## 18. SCORING

**18.1.** Time allowances will be per YRALIS PHRF procedures using time on distance and will be based on the course distance as indicated in Section 9 above.

## 19. SAFETY REGULATIONS

- **19.1.** All boats are cautioned to observe the Navigation Rules of the Road and to extend the right-of-way to commercial vessels, especially those restricted in their ability to manoeuvre, making passage through the racing area. Any boat observed to impede such traffic may be protested by the RC.
- **19.2.** A boat withdrawing before the start or retiring from a race for any reason is requested to notify the RC by VHF channel 72 at the earliest possible opportunity.

#### 20. RADIO COMMUNICATION

- **20.1.** Each boat shall carry a VHF radio capable of transmitting and receiving on channel 72.
- **20.2.** Except in an emergency, a boat shall neither make radio transmissions while racing nor receive radio communications not available to all boats. This restriction also applies to all mobile devices.
- **20.3.** The RC shall use VHF channel 72 for any radio communications with competitors. As an additional courtesy, radio prompts may be given to preface any actions by the RC. Boats shall not be entitled to redress for the following: misstatements by the RC, or failure of a boat to hear or receive a broadcast.

#### 21. PRIZES

- **21.1.** Prizes will be given as follows: Overall winner will receive the Little Brown Jug award.
- **21.2.** Prizes will be awarded for first, second, and third place finishers in both divisions.

#### 22. DISCLAIMER OF LIABILITY

**22.1.** Competitors participate in the regatta entirely at their own risk. See RRS 4, Decision to Race. The organizing authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.

**22.2.** Each participating boat shall be insured with valid third-party liability insurance.
