# The Tall Ships Race Rudder Club of Jacksonville 7 May 2022

# 1. RULES

The Race will be governed by the Racing Rules of Sailing, the prescriptions of the United Sates Sailing Association, and the PHRF rules of the First Coast Sailing Association.

### 2. ADVERTISING

Advertising is permitted in accordance with ISAF Regulation 20.3.

### 3. ELIGIBILITY

3.1 All boats must have a valid PHRF rating from FCSA. Boats not having a valid rating may obtain an uncontestable temporary PHRF rating on a one-time basis, assigned by the Rudder Club in accordance with FCSA Rules.

3.2 Eligible boats may enter by completing registration with the Rudder Club, which is the organizing authority.

3.3 Entrants in the Tall Ships Race must have a mast height of 44 feet or more.

3.4 Entrants will be divided into the following categories:

# Multihull Cruisers Monohull Cruisers Spinnaker Non-spinnaker

3.5 Boats whose configuration does not conform to that prescribed by the class rules for the boat shall indicate this on their race registration.

3.6 A minimum of three boats is necessary to constitute a class for race and trophy purposes.

3.7 Registration is online only at Regatta Network,

The deadline for registration is Sunday May 1 at 10:00 am (corrected)

#### 4. FEES

4.1 Advance registration before Sunday 24 April at 11:00 pm: \$75.00. Assistance will be provided to register on line on Saturday 23 April from 3:00 pm to 5:00 pm at the Rudder Club.

4.2 Registration between Sunday 24 April at 11:01 pm and Sunday 1 May at 10:00 am: \$95.00.

4.3 Rudder Club and Palatka Yacht Club members: \$5.00 discount.

4.4 US Sailing member: \$5.00 discount. Membership will be checked automatically at the time of registration.

### 5. SCHEDULE

5.1 Packet Pickup: Race packets will be available at the Skippers Meeting Sunday 1 May at 3:00 pm. Packets may be picked up at the Rudder Club during normal business hours from Tuesday 3 May through Friday 6 May.

5.2 Final Race Packet Pickup will be at the Rudder Club from 5:30 pm to 6:30 pm on Friday, 6 May.

5.3 Optional Competitors' Meeting: Sunday 1 May at 3:00 pm at the Rudder Club. Attendance is not mandatory.

5.4 Complimentary docking will be available at the Rudder Club the night prior to the race.

5.5 The warning signal of the race will be given at 10:00 am on Saturday 7 May.

5.6 Per Coast Guard regulations, any boat which has not finished by 8:09 pm shall be scored DNF.

### 6. MEASUREMENT

All boats are subject to measurement by the Race Committee at any time. To be eligible for entry a boat must have a mast height greater than 44 feet above the water.

### 7. SAILING INSTRUCTIONS

The Sailing Instructions will be posted at the Regatta Network site,

<u>https://www.regattanetwork.com/event/23913</u>, available at the optional Competitor's Meeting Sunday 1 May at 3:00 pm at the Rudder Club, and posted on the Bulletin Board. The Bulletin Board will be on the North Wall of the Rudder Club.

#### 8. COURSE

8.1 The Starting Line will be southeast of the center span of the Buckman Bridge at approximately N30 11.1 W81 39.7. The right (west) end of the Starting Line is the Race Committee Boat. The left (east) end of the line will be an orange cylinder.

8.2 The course is from the Starting Line to a mark north of the Shands Bridge at approximately N29 59.5 W81 38.6 (approximately 12 miles from the Starting Line. Boats will leave the mark to Port and return to the Finish Line.

8.3 The Finish Line has the Race Committee Boat at the right (east) end and an orange cylinder on the left (west) end.

#### 9. VENUE

The racing area is the St. Johns River between the Buckman Bridge (I-295) to the north and the Shands Bridge (Florida 16) to the south. The racing area is depicted on NOAA Chart 11492.

# 10. SCORING

10.1 The race will be scored using Time-on-Time in accordance with PHRF rules and assigned Time Correction Factors (TCF) noted on each PHRF certificate.

10.2 Corrected time will be the boat's elapsed time times the TCF .

### 11. RADIO COMMUNICATIONS

11.1 While racing, except in an emergency, a boat shall neither make radio transmissions nor respond to radio communications not available to all boats.

11.2 This restriction also applies to mobile telephones.

11.3 Communication with the Race Committee and support boats shall take place on Marine VHF Channel 78. Boats, where equipped, shall also maintain a listening watch on Channel 16.

11.4 DSC boats are encouraged to have an assigned MMSI (Maritime Mobile Service Identity) and a working GPS connected to or integral to their VHF radio. Boats may obtain a free MMSI at <a href="http://www.boatus.com/mmsi/">http://www.boatus.com/mmsi/</a>.

11.5 It is strongly recommended that all boats have a VHF radio or mobile telephone on board in case of emergency.

12. PRIZES

The Grace Rogers Trophy will be awarded to the first boat to finish (uncorrected time). Class trophies will be awarded based on corrected time.

### 13. DISCLAIMER of LIABILITY

Sailing is an activity that has an inherent risk of damage and injury. Competitors in this regatta are participating entirely at their own risk. See RRS 4, *Decision to Race*. Completion and submission of a registration form for this regatta constitute an acceptance of and agreement to abide by the Racing Rules of Sailing, this Race Notice and the Sailing Instructions.

# 14. INSURANCE

Each participating boat shall be insured with valid third party liability insurance. This rule is not protestable.
