# **NOTICE OF RACE**

The Neuse Yacht Racing Association, with assistance from Blackbeard Sailing Club, is the Organizing Authority for this regatta.

# 1 RULES:

- 1.1 The Regatta will be governed by the current Racing Rules of Sailing; the prescriptions of USSailing; the N.C. Wildlife Commission; and U.S. Coast Guard safety regulations.
- 1.2 NYRA encourages safe COVID practices by all participants.

# 2 ELIGIBILITY & ENTRY:

- 1. The race is open to boats holding a current NC-PHRF Rating Certificate. A NC-PHRF Rating Request form is available at <a href="https://www.ncphrf.com">www.ncphrf.com</a>
- 2.2 Racing will be conducted for Spinnaker, Non-spinnaker, multi-hulls, and Cruising boats.
  - 2.2.1 The following criteria applies to Cruising boats:
    - (a) no spinnakers are permitted;
    - (b) powered winches and auto-pilots are permitted;
    - (c) boats must not have been specifically designed for racing;
- 2.3 Eligible boats may enter by completing an entry form online at <a href="https://www.regattanetwork.com/event/24288#\_home">https://www.regattanetwork.com/event/24288#\_home</a>, and paying the required fees to NYRA by 1930 on March 20th. Late entries, subject to an additional late fee) may be accepted via online registration until 1930 on March 24th.

#### 3 FEES

Fees for competing and social event are described on the Registration Form attached hereto.

#### **4 RACING FORMAT & CLASSES**

- 4.1 Classes are offered for spinnaker, non-spinnaker, cruising, and multi-hull boats.
  - 4.1.1 A minimum of three boats will constitute a class.
  - 4.1.2 Depending on the number of entries, classes may be divided based on PHRF ratings.
- 4.2 Spinnaker, non-spinnaker, and multi-hull classes will sail either windward/leeward or triangle courses on Saturday.
  - 4.2.1 as many as 3 races may be run.
- 4.3 The cruising class will sail 1 medium distance race with modified pursuit starts on Saturday.
  - 4.3.1 Boats will be divided into rating bands each of which will have its own start.
- 4.4 Sunday racing will be "pursuit style" for all boats wherein a boat's handicap is pre-applied.
  - 4.4.1 Rule 26 will apply to the first start only.
  - 4.4.2 Subsequent start times will be determined by the length of the course and each boat's PHRF handicap. This changes rule 26.

- 1800 Shore Party and Annual Awards Ceremony at Lawson's on the Creek, at the NC History Center (catered by a Pinch of Love Catering) This social will serve as NYRA's annual awards ceremony, with awards for Boat of the Year, Crew of the Year, and Sportsman of the Year, as well as recognition of the winners of the 2021-22 Winter Series Regatta

- 7.1 Racing will be conducted on the Neuse River off Broad Creek in vicinity of markers 17/19/2
- 7.2 Social event Saturday at Lawson's on the Creek, History Center, 529 S Front Street, New Bern, NC
- 7.3 Overnight docking at BSC may be available. Contact <a href="bod@nyra.org">bod@nyra.org</a> for information.

#### 8 COURSES:

Courses to be sailed will be defined in the Sailing Instructions.

# 9 SCORING:

- 9.1 The Low Point Scoring System, RRS Appendix A, will apply.
- 9.2 Corrected times will be determined using time-on-time calculation.
- 9.3 On Sunday, finish order determines finish place.
- 9.4 One completed race will constitute the regatta.

# 10 COMMUNICATION:

- 10.2 The race committee will monitor and broadcast on VHF Channel 78A.

#### 11 PRIZES:

Prizes will be awarded based on numbers of entries in each class and for overall in each fleet.
