NOTICE OF RACE

History of the Lighthouse Regatta: The annual Lighthouse Charity Regatta is a fundraising event for the OKC Lighthouse Charity (LCI). The funds from this regatta are used to provide scholarships for underserved children in the OKC community to attend one, or more, week-long summer youth sailing camps held at OCBC. Past recipients of sailing scholarships include the Little Light Christian School, Boys and Girls Club, Peppers Ranch and the Single Parent Support Network. LCI is staffed by volunteers with the only paid positions are our youth sailing coaches who run the summer camps in June, July and August each year.

Where: OCBC on east shore of Lake Hefner, 1/4 mile south of Britton Rd, N 035 33.765' W 097 34.541' Take Britton Rd west to its end, turn south to the East Wharf Entrance, keep left through the OCBC gate.

Centerboard and Multi-Hull Registration: Registration is \$50 per boat. This includes the skipper and one crew. Meal included with the registration is breakfast Saturday prior to the races. Lunch provided after racing. Each additional crew member is \$10 and includes their breakfasts and lunch. *Registration after June 1st, 2022 is \$70 per boat.*

Keelboat Registration: Registration is \$100 per boat. This includes the skipper and two crew. Meals included with the registration are breakfast Saturday and Sunday prior to the races. Saturday lunch fixings provided for lunch on the water. Each additional crew member is \$10 and includes their breakfasts and lunch. *Registration after June 1st, 2022 is \$125 per boat.*

Saturday, June 25, Dinner: \$30 per person. This includes dinner, dessert, beverages and entertainment..

From the North: Take I-35 to the Kilpatrick Turnpike west. Exit on Lake Hefner Parkway south to Britton Road and go west.

From the South: Take I-35 to I-240. Go west to I-44. Go north to Lake Hefner Parkway (74N) and continue north. Do not follow the I-44 exit to Tulsa. Exit at Britton Rd and go west.

Facilities: Clubhouse with restrooms, ramps and hoists for launching boats (help will be available), limited wet slips and limited overnight camping on premises. Several hotels and restaurants are available within a few minutes driving time.

Authority: Lighthouse Charities, Inc. (LCI) and Oklahoma City Boat Club (OCBC)

Rules: All races will be governed by the "**rules**" as defined by the 2021-2024 Racing Rules of Sailing (RRS) @ <http://www.ussailing.org/race-officials/rules/rulebook/>

Classes: There must be a minimum of 3 boats to determine a class.

Eligibility: Open to any member in good standing of a recognized sailing organization with registration. Donations to Lighthouse Charities are suggested.

Sailing Instructions: Will be available at registration.

Registration: All registration is to be completed online. OCBC members will be available during Registration hours to assist in the online registration process.

Scoring: Low Point scoring by Appendix A as modified by the Sailing Instructions. Five races are scheduled, one race constituting a regatta.

Substitution: Crew may not be substituted between races without prior written permission from the Race Committee.

Measurement: All boats must be valid one-design boats acceptable to the local fleet, to race in a one-design fleet. All other boats will race in a PHRF handicap division and must present a valid PHRF certificate. For boats without valid rating certificates, the local rating committee will issue a temporary certificate.

Courses: Courses will be determined and announced by the Race Committee in accordance with the Sailing Instructions.

Appeal: Decisions of the Protest Committee with regard to protests, requests for redress and other actions by the Race or Protest Committee shall be subject to appeal according to rule 70 of the RRS.
