Notice of Series

1. RULES

- 1.1 Each regatta will be governed by the Rules as defined in 2021-2024 Racing Rules of Sailing, the prescriptions of US Sailing, plus the Notice of Race & Sailing Instructions issued by the organizers of each individual regatta.
- 1.2 This Notice of Series makes no attempt to replace or alter the Rules and documents listed above, nor does it attempt to regulate the format of individual regattas. The primary purpose of this Notice is to establish eligibility and scoring criteria which will be used to extract Grand Prix Series points from existing regattas.
- 1.3 Eligible competitors entered in the ILCA NA District 22 Grand Prix Series shall observe and enforce ILCA class rules.
 - 1.3.1 A discretionary penalty [DP] may be applied to a competitor's Grand Prix Series points score if they break an ILCA class rule, but not unless there is first
 - a) a written protest received by the series chair within 48 hours of the alleged rule(s) violation and
 - b) a hearing is convened with the series chair, and at least one other member who is either an ILCA class representative, race committee member, or certified judge.

2. ELIGIBILITY & ENTRY

- 2.1 This series is open to all current members of the International Laser Class Association. Membership is obtained through ILCA-NA at [laser.org/join](https://www.ilca.org/join)
- 2.2 ILCA membership will be verified at the time of series registration and checked after each regatta.
- 2.3 Competitors must enter the series prior to the first regatta in which they participate, by registering through the Regatta Network link found here: <https://www.cgra.org/>
- 2.4 Competitors may register for the series at any stage of the series, but no races entered prior to registration in the series shall count.
- 2.5 There is no ILCA District 22 Grand Prix Series entry fee. Competitors must register and pay separately for each individual regatta through the host club.
- 2.6 Each regatta within this series is open to Laser 4.7/ILCA 4, Laser Radials/ILCA 6 , and Laser Standards/ILCA 7, unless stated otherwise.

2.7 At the time of registering for the series, a competitor shall select the class in which they will compete. This may be changed up until a competitor sails their first regatta.

SSP Octoberfest is for YOUTH ONLY and for ILCA 6 and 4.7 only.
- Turkey Bowl (November 19-20 @ CYC Seattle)

Separate Sailing Instructions and Notices of Race shall be published by each host club.

4. SAILING INSTRUCTIONS AND NOTICES OF RACE

5. SCORING

5.1 Individual regattas shall be scored in their usual manner by host clubs.

5.2 The ILCA District 22 Grand Prix Series results shall be calculated using a modified High Point Scoring methodology. A competitor's overall finishing position at the end of each regatta shall be used to determine the number of points earned for that regatta, not the individual races within the regatta.

5.3 Point values for each ILCA District 22 Grand Prix Series regatta are calculated as follows: $(N-X) + 1$, where number of Grand Prix entries (N) minus overall finishing position (X), plus one (+1), equals the number of D22 Grand Prix Series points earned.

5.3.1 The District 22 Championships Regatta shall be scored using the same point system as all the other regattas in the District Grand Prix Series. The District Grand Prix Series points are NOT valued into the ILCA-NA Grand Prix series. The results of the District Championship Regatta points will apply to the NA Grand Prix points system without regard to the District Grand Prix Series finishes.

5.4 The following competitor's shall receive zero (0) points and be excluded from regatta results when calculating District Grand Prix point totals:

5.4.1 Competitors who appear in regatta results, but fail to finish at least one race in that regatta.

5.4.2 Competitors who appear in regatta results, but do not meet series eligibility requirements.

5.4.3 Competitors who appear in regatta results, but did not register for the ILCA District 22 Grand Prix series prior to the start of the regatta.

5.5 There is no minimum number of entries in the regatta required in order to earn Grand Prix Series points. The minimum number of entries shall be established at the discretion of each host club. However, one must compete in at least 3 regattas to be eligible for the final award.

5.6 A competitor's total series score shall be the sum of their regatta point totals for all applicable District 22 GP Series regattas the individual competes in, but only in the GP class for which they registered.

5.7 In the event of a tie between two or more boats in the overall ILCA District 22 Grand Prix Series standings, the tie breaking formula described in Appendix A (Rule A8) shall be used, except that regatta scores shall be used in place of scores from individual races. Ties which do not affect the standings of the top-5 shall stand.

5.8 ILCA 4, ILCA 6, and ILCA 7 classes shall be scored separately. Only scores from the class selected during series registration shall count toward a competitor's District Grand Prix Series points total.

6. AWARDS

Overall winners and runners up of each division shall be recognized. Prizes will be awarded by ILCA District 22.

7. DISCLAIMER OF LIABILITY

Competitors participate in this series entirely at their own risk. See Rule 4, Decision to Race. The North American Laser Class Association, supporters, and sponsors of this series will not accept any liability for property damage, personal injury, or death sustained in conjunction with, prior to, during, or after any ILCA District 22 Grand Prix Series regatta.
