RULES

1

1.1 The Regatta will be governed by the current Racing Rules of Sailing, together with the rules of the participating classes and any additional sailing instructions to be issued at the competitors' meeting.

ELIGIBILITY AND ENTRY

2.1 The regatta is open to boats of the Albacores, Chesapeake 20, Flying Scot, and A-Class Catamaran Classes.

First warning signal for all classes
No races will start after this time

Awards will follow racing.

8.3 Number of Races:

There is no limit to the number of races. The committee will attempt to maximize racing for the conditions available.
