NOTICE OF RACE

1 RULES

- 1.1 The regatta will be governed by the rules as defined by *The Racing Rules of Sailing*
- 1.2 US Sailing prescriptions will apply except the prescriptions to RRS 63.1 and 63.2.
- 1.3 Appendix S, Standard Sailing Instructions, will apply except as amended in *the Supplement*.

2. ADVERTISING

2.1 Boats may be required to display advertising chosen and supplied by the organizing authority. If this rule is broken, World Sailing Regulation 20.9.2 applies [DP].

3 ELIGIBILITY and ENTRY

- 3.1 The regatta is open to centerboard boats of the ILCA 4 (4.7), ILCA 6 (Radial), and ILCA 7 (Laser), V15, 420, 470, and Lightning Classes. Additional centerboard classes may be invited. Five or more boats are required to be scored as a fleet and be given a separate start. If fewer than 5 boats of a one-design fleet are present, fleets may be combined and scored based on a Portsmouth handicap rating.
- 3.2 ILCA competitors must be a current member of the ILCA-North America or their national Laser class association
- 3.3 Eligible boats may enter by completing the online registration at <u>www.milwaukeeyc.com/on-the-water/regattas</u>. Registration fees and waivers will be completed through this registration.
- 3.4 Late entries will be accepted up until 1000 on August 6, 2022
- 3.5 The following restrictions on the number of boats will apply: no more than 30 boats in each accepted class.

- 5.1 Seven races are planned for all fleets
- 5.2 On the last scheduled day of racing, no warning shall be made after 1600 hours.

6. SAILING INSTRUCTIONS

- 6.1 Appendix S, Standard Sailing Instructions, will be used, except as modified by *The Supplement.*
- 6.1 *The Supplement* and this NOR will be published online at the ILCA website and available at registration via QR code posted at the Official Notice Board. This meets the requirements of the prescriptions to RRS 25.1

7 VENUES

7.1 Attachment A shows the location of the racing areas. The primary racing area will be in the open waters of Lake Michigan approximately 0.5nm East of the North Harbor Gap. In the case of inclement weather, the alternate racing area will be inside the Government Breakwall.

8 PERSONAL FLOTATION DEVICES

8.1 RRS 40.1 applies at all times when afloat.

9 SCORING

- 9.1(a) When fewer than five races are completed, a boat's series score will be the total of her race scores. This modifies RRS A2.1
- 9.1(b) When five or more races are completed, a boat's series score will be the total of her race scores excluding her worst score.
- 9.2 One completed race is required to constitute a regatta.

10 SUPPORT BOATS

10.1 Support Boats shall be marked with an orange flag [DP]

11 BERTHING

Boats may be kept in the MYC dry dock area or in the flushing channel area adjacent to MYC at the permission of the MYC Harbor Master.



12. PRIZES

Prizes will be given as follows:

If less than 5 boats in each class: 1st place only If more than 5 boats in each class: 1st, 2nd, & 3rd place will be awarded Additional Prizes may be awarded.

13 DISCLAIMER OF LIABILITY

Competitors participate in this regatta entirely at their own risk. See RRS 3 *Decision to Race* and RRS 4 *Acceptance of the Rules*. The organizing authority will not accept liability for material damages or personal injury, or death sustained in conjunction with or prior to, during, or after the regatta.


14 INSURANCE
