

# Florida State J/24 Championship August 20 & 21, 2022 Coconut Grove, FL. NOTICE OF RACE

#### 1. Rules

- 1.1. The Organizing Authority is the Coconut Grove Sailing Club and the J/24 Biscayne Bay Fleet 10.
- 1.2. This regatta will be governed by the rules as defined in The Racing Rules of Sailing.

# 2. Eligibility

- 2.1. The regatta is open to all J/24 sailboats as defined by the IJCA and each boat must possess a valid measurement certificate.
- 2.2. Competitors must meet all ownership and class membership requirements and complete all aspects of the registration process.

# 3. Entry and Fees

- 3.1. A completed entry form must be received no later than 1000, August 17, 2022.
- 3.2. Regatta Entry Fee: \$120.00.
- 3.3. Registration fee includes all racing and social events.
- 3.4. Boats shall enter the event by completing the on-line registration and paying the entry fee on the event website,

- 3.5. All boats will be stored at CGSC.
- 3.6. Launching/Hauling is not available at CGSC and is not included w/ Entry.

#### 5. Inspection

- 5.1. All boats are subject to random inspection or measurement by the Race Committee at any time during the Regatta for Rules Compliance.
- 5.2. No boat will be allowed to compete without a fully completed and compliant Part D Class Measurement and Inventory of Required and optional Equipment forms.
- 5.3. All participants will be subject to verification of declared crew weight per Class Rule 5.1 and encapsulated corrector weights per Class Rule 3.7.2.

#### **6. Sailing Instructions**

- 6.1. Sailing Instructions will be available at the completion of registration.
- 6.2. Changes to the Sailing Instructions will be posted no later than 15 minutes after the Competitors' Meeting to be effective on Saturday, August 20th, or 0800 on Sunday, August 21st to be effective on that date.
- 6.3. On-the-water changes may be made to the Sailing Instructions in accordance with Rule 89.2[c] after Flag L is displayed.

### 7. Regatta Venue

- 7.1. Coconut Grove Sailing Club, 2990 South Bayshore Drive, Miami, Florida, 33133.
- 7.2. Vehicle parking on Club property available <u>only</u> for Club members.
- 7.3. Trailers must be stored off property.
- 7.4. Competitors will be permitted to use all facilities including showers and docks **WITH** limited parking and trailer storage for CGSC members only.
- 7.5. If you have any symptoms of Covid-19 or are feeling unwell, please respect the club members, club employees and other competitors and stay away from the event premises and competitors.

# 8. Racing Area

The Racing Area will be on Biscayne Bay SE of Brennan Channel, just beyond Middle Ground Shoal and south of Dinner Key Channel.

#### 9. Courses

The courses will be Windward/Leeward courses with drop marks per the Sailing Instructions.

# 10. Scoring

10.1. The Low Point scoring system RRS Appendix A will be modified such that a boat's worst

score will be excluded after completion of six races.

10.2. Seven (7) races are scheduled of which one (1) shall constitute a Regatta. This modifies Rule A2.

#### 11. Alternative Penalties

The scoring penalty rule 44.3 will apply when a boat may have broken a Rule in Part 2 of the RRS.

#### 12. Prizes

Prizes will be awarded for the top three places.
