1 RULES

- 1.1 The regatta will be governed by the rules as defined in *The Racing Rules of Sailing*.
- 1.2 Competitors and support persons shall comply with any reasonable request from an event official. Failure to comply may be misconduct.

2 ELIGIBILITY AND ENTRY

- 2.1 Competitors and coaches shall enter by completing the on-line entry form on the event website <https://www.regattanetwork.com/event/25411> and paying the required fees. Entries must be received no later than 1800, Nov 25, 2022.
- 2.2 Competitors under 18 years of age shall present a signed and completed parent (or guardian) consent and declaration form at check-in. The forms are available for download on the event website.
- 2.3 The regatta is open to any monohull boats with center or dagger board. Anticipated Classes: Optimist (Green, White/Blue/Red), ILCA 7, ILCA 6, ILCA 4, and C420.
- 2.4 Parents of competitors will be given 2 drink tickets for the bar to use during the DIYSF Youth Sailing Auction on Saturday. Tickets must be used after the Silent Auction begins which is after 1400. Havana themed menu will be served from the kitchen after 1630.

3 FEES

- 3.1 Optimist or ILCA \$96.75 (\$90 plus 7.5% sales tax)
- 3.2 C420 \$129.00 (\$120 plus 7.5% sales tax)
- 3.3 The entry fee includes a regatta t-shirt for skipper and all crew; coffee, juice, and donuts for competitors both Saturday and Sunday; and awards as described here in.
- 3.4 LATE FEE – Entries received after midnight November 19 will be charged an additional \$20, and are not guaranteed to receive t-shirts.

5 VENUE

All classes will race in Hillsborough Bay South of DIYC.

6 SAILING INSTRUCTIONS

Sailing Instructions will be available at check-in and earlier on the event website. Other documents governing the event will be published with the sailing instructions.

7 SCORING

- 7.1 Many races are scheduled. One race for a class or fleet must be completed to constitute a regatta.
- 7.2 When 5 of more races have been completed, a boat's series score will be the total of her race scores excluding her worst score.

8 SUPPORT VESSELS AND PERSONNEL

- 8.1 All support vessels shall be registered with the organizing authority and will be required to comply with event support vessel requests.
- 8.2 Except when assisting the Optimist Green Fleet competitors, support vessels with team leaders, coaches and other support personnel shall stay outside areas where boats are racing from the time of the preparatory signal for the first fleet to start until all boats have finished or the race committee signals a postponement, general recall or abandonment.
- 8.3 All outboard-equipped support vessels shall be equipped with a functioning engine safety cut-out switch (kill switch) which shall remain attached to the support person (operator) at all times when the engine is on. Support vessels shall check-in with the RC Signal vessel before the first race of each day to demonstrate compliance. Failure to comply may be misconduct and result in expulsion from the event.

9 PRIZES

Prizes will be awarded to the top 3 boats in each fleet. Thanks for Coming gifts will be given to all Optimist Green Fleet competitors.

10 DISCLAIMER OF LIABILITY

Competitors participate in the regatta entirely at their own risk. See RRS 3, Decision to Race. Neither the organizing authority nor race committee will accept any liability for material damage or personal injury, illness, disease, or death sustained in conjunction with or prior to, during, or after the regatta.

11 MEDIA RIGHTS, CAMERAS AND ELECTRONIC EQUIPMENT
