## **NOTICE OF RACE**

### **1 RULES**

- 1.1 The regatta will be governed by the rules as defined in *The Racing Rules of Sailing* (RRS) US Sailing 2021-2025.
- 1.2 PHRF-NE 2023 rating certificate will be required for each yacht.

### **2 ELIGIBILITY AND ENTRY**

- 2.1 The regatta is open to all boats of the PHRF-NE Racing and Cruising classes.

### **3 FEES**

- 3.1 Required fees are as follows:  
*Entry Fee: \$60.00 per yacht* – Fee includes awards giving dinner social (Pig Roast with a Live Band) ticket for the skipper.

## 5 **SAILING INSTRUCTIONS**

The sailing instructions will be available at the skippers meeting and on line prior to the scheduled first race.

## 7 **THE COURSES**

The courses to be sailed will be as follows:

Navigation able waters between Gunboat Shoals, Little Boars Head, Isle of Shoals, and Murry's Rock using government marks. Course requirements will be disclosed at the pre race skippers meeting along with the sailing instruction.

## 8 **PENALTY SYSTEM**

8.1 For all classes rule 44.1 is changed so that the Two-Turns Penalty is replaced by the One-Turn Penalty.

## 9 **SCORING**

9.1 The scoring system is as follows: Pursuit Format.

## 10 **RADIO COMMUNICATION**

Except in an emergency, a boat shall neither make radio transmissions while racing nor receive radio communications not available to all boats. This restriction also applies to mobile telephones. The Race Committee and chase boats will be using and monitoring VHF Channel 68.

## 11 **PRIZES**

Prizes will be given as follows:

**John Paul Jones Race:** 1<sup>st</sup>, 2<sup>nd</sup>, & 3<sup>rd</sup> place trophies in PHRF Racing, Racing B, and Cruising Fleets – Winners of each class will have yacht name and skippers name engraved on the Perpetual Trophy that is housed at Kittery Point Yacht Club.

**12 DISCLAIMER OF LIABILITY**

Competitors participate in the regatta entirely at their own risk. See rule 4, Decision to Race. The organizing authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.

**13 INSURANCE**

Each participating boat shall be insured with valid third-party liability insurance with a minimum cover of \$300,000.00 per incident or the equivalent.
