### AMENDMENT ONE

Please note the following changes to the Notice of Race and Sailing Instructions.

#### Current Text

#### 14. The Start

14.1 Races will be started using Appendix U, Audible-Signal Racing System, of the US Sailing Prescriptions, as modified below:

14.1.1 Appendix U3. The starting sequence shall consist of the following sound signals made at the indicated times. These signals shall be timed from their commencement.

Signal	Sound	Time Before Start
<b>Attention</b>	Series of short sounds	Before the warning
<b>Warning</b>	5 long	5 minutes
<b>Preparatory</b>	4 long	4 minutes
	1 long	1 minute
<b>Starting</b>	1 long	0

14.2 The starting line will be between a staff displaying an orange flag on the race committee signal boat and the course side of the port-end starting mark.

14.3 U4 Individual recalls shall be signaled by hailing the sail number of each recalled boat. Flag X will not be displayed.

## Revised Text

### 14. The Start

14.1 Races will be started using Appendix U, Audible-Signal Racing System, of the US Sailing Prescriptions, as modified below:

14.1.1 Amended Appendix U3 The starting sequence shall consist of the following sound signals made at the indicated times. These signals shall be timed from their commencement. There will be no supporting visual signals.

Signal	Sound	Time Before Start
Attention	Series of short sounds	Before the warning
Warning	<b>1 long</b>	5 minutes
Preparatory	<b>1 long</b>	4 minutes
	<b>1 long</b>	1 minute
Starting	<b>1 long</b>	0

14.2 The starting line will be between a staff displaying an orange flag on the race committee signal boat and the course side of the port-end starting mark.

14.3 U4 Individual recalls shall be signaled by hailing the sail number of each recalled boat. Flag X will be displayed.

## 16. Protests and Requests for Redress

- 16.1 Protest forms are available upon request from the PRO. Protests and requests for redress or reopening shall be delivered within the appropriate time limit.
  - 16.2 The protest time limit is 30 minutes after the race committee boat docks after the last race of the day. The time of docking will be signaled by a sound.
  - 16.3 Notices will be posted within 30 minutes of the protest time limit to inform competitors of hearings in which they are parties or named as witnesses and the location of the hearings.
  - 16.4 Notices of protests by the race committee or protest committee will be posted to inform boats under RRS61.1 (b).
  - 16.5 Breaches of SIs 13.1, 14.1.1 (U3) 14.3 (U4) 17.2, 17.3 and 18 shall not be grounds for redress.
