

NOTICE OF RACE

June 10th-11th 2023 Perry Lake, KS



Organizing Authority: Perry Yacht Club in conjunction with Hobie Fleet 149.

Rules: The regatta will be governed by the rules as defined in the *Racing Rules of Sailing*

Sailing Instructions: The sailing instructions will be available after June 1st on RegattaNetwork.com.

Communications: The official notice board will be at the northwest corner of the PYC pavilion. An unofficial notice board will be on RegattaNetwork.com. Sailors may bring and use a VHF radio capable of communication on channels 16 and 69.. Its use and restrictions will be described in the SIS.

Eligibility & Entry: The event is open to all beach catamaran designs. Skipper and/or crew must be 2023 HCA-NA members or pay a 25 dollar weekend fee <http://hcana.hobieclass.com/join/> ('HCA Rule 26). With all minimum of 3 boats to make a class, Hobie one design and other one design catamaran classes will race one design fleets. All other Beach Catamarans with 2 or fewer boats in a class will complete in an open class using the SCHRS rating system. If no valid rating is available, the Organizing Authority will assign a provisional rating.

Registration & Fees: \$70 For single Handed Catamarans, \$90 for double handed Catamaran registered before June 1st, 2023; \$15 late fee applies thereafter and may not include a Tshirt. **Skippers under the age of 21 race for free!** Registration includes racing, food, shirts, social events. Food and drink passes are available at Regatta Network for non-competitor adults attending the event.

Awards as soon as possible after racing

The Race Committee intends to run 3 to 5 races per day, back to back. There is no maximum number of races.

Penalty System: In RRS 44.1 “A boat may take a Two-Turns Penalty...” is replaced with “A boat may take a One-Turn Penalty ...”.

Scoring: A boat’s series score shall be the total of her race scores. One race is required to constitute a series.

Venue: Perry Yacht Club, 8369 Yacht Club Dr, Meriden, KS 66512. Racing will be on Perry Lake.

Risk Statement: Refer to RRS 3. By participating in this event each competitor agrees and acknowledges that sailing is a potentially dangerous activity with inherent risks. These risks include strong winds and rough seas, sudden changes in weather, failure of equipment, boat handling errors, poor seamanship by other boats, loss of balance on an unstable platform and fatigue resulting in increased risk of injury. Inherent in the sport of sailing is the risk of permanent, catastrophic injury or death by drowning, trauma, hypothermia or other causes.

Insurance: Each participating boat shall be insured with valid third-party liability insurance with a minimum coverage of \$300k per incident or the equivalent.

Prizes: Winner of Each Class will be named the Wizard of Oz.
