#### DISCLAIMER OF LIABILITY

1.1. Sailing is an activity that carries with it an inherent risk of damage and injury, even death. Competitors participate in this regatta entirely at their own risk and are reminded to pay special attention to RRS 4, Decision to Race

1.2. The race organizers, including the Organizing Authority, Race Committee, Protest Committee, sponsors, volunteers or any other affiliated organization or official will not be responsible for damage to any boat or other property, or the injury to any competitor, including death, sustained as a result of practice for or participation in this event on the water or ashore

1.3 Participation includes possible exposure to and illness from infectious diseases including but not limited to MRSA, influenza, and COVID-19. While particular rules and personal discipline may reduce this risk, the risk of serious illness and death does exist; and EACH PARTICIPANT KNOWINGLY AND FREELY ASSUMES ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM NEGLIGENCE OF THE RELEASEES or others, and assumes full responsibility for their participation. Participants willingly agree to comply with the stated and customary terms and conditions for participation as regards protection against infectious diseases. If, however, a participant observes any unusual or significant hazard during my presence or participation, I will remove myself from participation and bring such attention to the nearest official; and,
