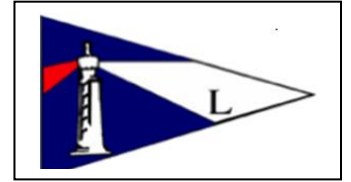

Rules: The regatta will be governed by the current Racing Rules of Sailing, the prescriptions of US Sailing and the rules of the International Sunfish Class Association, except as altered by the Sailing Instructions or as posted on the Official Notice Board.

Eligibility: Each competitor shall be a female current member of her respective country's Class Association affiliated with the International Sunfish Class Association (ISCA). Sailors not reaching the age of 19 by the end of 2023 shall be classified as a Youth. Sailors reaching the age of 40 or more by August 19, 2023 shall be classified as a Master. Registration must be completed online at Regatta Network. All competitors must check in on-site to complete registration.. By registering for this event you agree to abide by local COVID-19 regulations in effect.

Registration Fee: The registration fee will be \$80.00. There will be a \$5.00 discount for US Sailing members. Registration fee includes Breakfast, Lunch and Dinner on Saturday, Breakfast and Lunch on Sunday, a regatta souvenir and complimentary beverages following racing Saturday and Sunday.

SIs: Sailing Instructions will be available on regattanetwork.com or at registration.

Venue: The regatta will take place on the Delaware Bay near the Roosevelt Inlet. There may be other regattas using the same or nearby venues. The racing area is subject to significant tidal currents.

Courses: The courses will be windward–leeward, triangles, or combinations thereof.

Penalty System: Appendix P will apply.

Scoring: The Low Point Scoring System, RRS Appendix A2, shall apply. One race will constitute a regatta. A maximum of seven (7) races will be sailed. When fewer than four (4) races have been completed, a boat's series score will be the total of her race scores. When four (4) or more races have been completed, a boat's series score will be the total of her race scores excluding her worst race.

Measurement: Boats and equipment must be compliant with current International Sunfish Class Association rules. Boats may be selected for measurement at any time during the regatta by the ISCA Chief Measurer, or an appointed representative.

Insurance: The Organizing Authority recommends that each competitor shall be insured with valid third-party liability insurance.

Disclaimer of Liability: Competitors participate in the regatta entirely at their own risk. See Rule 4, Decision to Race. The organizing authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.

Awards: Trophies will be awarded to the top five overall finishers as well as top Master and top Junior. The top three (3) US finishers will automatically qualify for the 2023 US Pan American Games Trials.
