1. RULES

- 1.1. The event is governed by the rules as defined in The Racing Rules of Sailing.
 - 1.1.1. RSS 52 is modified to allow the use of autopilot for doubled and single-handed racers only.
 - 1.1.2. RSS 52 is modified to allow the use of powered winches.
 - 1.1.3. RSS 47 is modified to allow the use of banding for safety purposes.
 - 1.1.4. RSS 63.2 and 63.4 do not apply.

5. THE START

- 5.1. Your staggered start time will be given to you at the skippers meeting. The HYC digital clock will be used as the official time.
- 5.2. The starting line will be between the flagpole at HYC and a buoy in the turning basin.

6. THE FINISH

- 6.1. The finish line will be between the flagpole at HYC and a buoy in the turning basin.
- 6.2. All boats shall record their own finish time according to the HYC digital clock and report it to the Race Committee upon request.

7. SAFETY REGULATIONS

- 7.1.VHF Channel 68 is reserved for essential communications, otherwise yachts shall monitor VHF Channel 16.
- 7.2. Upon withdrawing from the race, yachts shall inform the race committee via VHF Channel 68, by voice hail, or by calling Travis Scott. (808) 383-3619

8.1.Competitors participate in the regatta entirely at their own risk. See RRS 4, Decision to Race. The organizing authority will not accept any liability for material damage or personal injury, or death sustained in conjunction with or prior to, during, or after the race.
