Eligibility: This event will be open to DISC members, mono hull keel boats 20 ft or greater, One Design

boats under 20. Some keel boats may be rejected based on keel depth. All PHRF entries must have a valid 2023 PHRF of the Chesapeake rating certificate or proof of a submitted application to PHRF of the Chesapeake. Boats without a PHRF certificate may be assigned a courtesy rating by the Organizing Authority. All participants should meet US Sailing Near-shore

requirements.

All entries must register online, sign all waivers, and pay regatta fees to be scored.

By participating and entering DISC races and regattas, the boat owner/skipper agrees to abide by the current Racing Rules of Sailing (RRS), the Daingerfield Island Sailing Club (DISC) Notices of Race, DISC Sailing Instructions, PHRF of the Chesapeake class rules, and applicable class rules. One Design rules may be modified to allow VHF radios, and electronic timing devises. By entering an event, the boat owner/skipper agrees that there are inherent risks to competitive sailing and, 1) they are solely responsible for the decision whether to enter or continue any race (RRS 3), and, 2) they shall hold harmless DISC and the DISC officers for any

damage or liability that may occur during a race or regatta.

Rules: This regatta will be governed by the 'rules' as defined in the current Racing Rules of Sailing.

Conflict between Rules, DISC Bylaws, PHRF of the Chesapeake class rules. "If there is a conflict between the Event Sailing Instructions and the Notice of Race, the Event Sailing

Instructions shall apply." this modifies RRS 63.7.

Sailing Instructions: DISC Event Sailing Instructions and Notice(s) of Change will be posted on

www.discsailing.org up until 2400 on Friday June 16, 2023. Notices will be posted on the sign

board outside the marina store on race day.

Rendezvous: A Skipper's Meeting will be held on the deck outside the marina store at Washington Sailing

Marina at 0930. On-water rendezvous at 1030 in the vicinity Potomac River 4 or at a location

determined by the Race Committee.

Start: At approximately 1045 between Potomac River R4 and the orange flag on the Race

Committee Signal Boat.

Classes: There will be at least one Spinnaker fleet, and one Non-spinnaker fleet offered. Other

fleets of 3 or more will be scored.

Signals: The RRS 26 Starting System will be used.

Radio: Competitors shall carry a VHF radio capable of receiving and transmitting on U.S. channels.

Course: Fixed government marks will be used. The course will be determined the day of each race.

Code letters will be posted on the Race Committee boat. It is anticipated that "Middle Courses" will be used. A description of all marks and their code letter designations is available under the

Racing Resources tab at WWW.discsailing.org. .

Finish: Between Potomac River 4 and the orange flag on the Race Committee Signal Boat or at a

location determined by the Race Committee. This modifies RRS Appendix S11.1 and race

signals.

Time Limit: 1.5 hours per race. No races will start after 1500.

Scoring: Races will be scored using "low point" scoring system, "Time on Time" calculations will be used

to determine corrected finish times for PHRF entries. PHRF of the Chesapeake CR (circular

random) ratings will be used. This event will be part of the DISC weekend series.

Protests: The Race Committee must be informed of the intent to protest upon finishing or retiring. The

time limit for submitting the protest form in writing will be 45 minutes after the last boat finishes.

Protest forms must be handed to the Standing Race Committee, or emailed to

officers@discsailing.org within the time limit.

Races: It is intended to have three races, one race constitutes a regatta

Waiver: All participants (including crew) will be required to sign a waiver.

Awards: 1st place trophies for classes of 3 or less, 1st, and 2nd place trophies for classes of 4 or less, and

1st, 2nd, and 3rd place trophies for classes of 5 or more

Other: Daingerfield Island Sailing Club (DISC) will sponsor this regatta on the upper Potomac in the

waters around Alexandria, VA and Washington, DC. Participating boats without a valid PHRF of the Chesapeake rating may be assigned a courtesy rating by the RC. Boats participate in this regatta entirely of their own volition (see RRS 3, Decision to Race). DISC will not accept liability

for damage or injury resulting from an incident arising before, during, or after the regatta.

Shore amenities: Three 1 ton cranes and two launch ramps are available for launch and recovery. Some limited wet slips may be available through Washington Sailing Marina, 1 Marina

Drive, Alexandria, VA on a first come basis at a discounted price.

There will be an after race party in the grove at Washington Sailing Marina. Trophies will be

awarded at the annual meeting

The following rules have been modified in the Regatta Sailing Instructions:

RRS 63.7 Conflict Between Rules, Sailing Instructions will apply

RRS 62.1 **Redress.** All radio communication will be a courtesy. No Redress given for failure to receive or understand a radio transmission.

RRS 23, Interfering With Another Boat, Sailing in the area of the finish line after racing

RRS 32.2 Shortening The Course, changes procedure and finish line

RRS 44.1, 44.2, 44.3, **Exoneration, Penalties At The Time** Of **An Incident,** collision with the Race Committee boat, the penalty is to retire

RRS definitions, A3, **Sailing The Course, Starting Times And Finishing Places,** Race Committee can finish competitors where they stand.

RRS 60.2, **Right To Protest**, Race Committee can protest a boat that interferes with commercial traffic with information from any party including a party with a *conflict of interest*.

RRS 60.1 **Right To Request Redress**, All boats must check in to be scored, no redress given. All radio transmissions are a courtesy, no redress.

RRS **60.2**, **60.3a**, **40**, **Y Flag Rules**, Race Committee can protest violations of rule, can receive information from a person with a *conflict of interest*.

RRS **Appendix S11.1**, race signals. Finish will be an orange flag.
