1. RULES

This race will be governed by the *rules* as defined in the *Racing Rules of Sailing*.

2. ELIGIBILITY

Spinnaker class is open to all boats with current PHRF ratings; non-spinnaker class is open to any boat at least 22ft LOA. If a boat does not have a current PHRF rating, the Race Committee (RC) may assign a rating for purposes of this race only. Area A Random Leg Course (RLC) handicap ratings will be used for scoring.

3. RACE ENTRY & FEES

Race entry will be online only (<https://www.regattanetwork.com/event/26591>) and will close at 1800, Friday, June 23. Entry fees are \$30 for US Sailing Association and CIYC members, \$35 for non-members of USSA or CIYC.

5. RACING AREA

The racing area will be the coastal waters of Ventura County. The race will begin near the Mandalay race buoy and finish in the same area. Courses will be chosen from the 2023 Wild Bill Rig Race Course Chart, which includes course distances up to approximately 22nm and one or more oil platforms as marks in each course. Any associated mooring buoy(s) are also marks of the course.

6. COMMUNICATION

The official notice board is located online at <https://www.regattanetwork.com/event/26591>. All boats shall carry a VHF radio capable of communicating on Channels 16 and 68.

7. HOSPITALITY & PRIZES

After racing, all skippers and crew are invited to Channel Islands Yacht Club (CIYC) for hot food, no-host bar, and individual and perpetual race awards. The Wild Bill Rig Race Perpetual Trophy will be engraved with the winners' names and classes and displayed at CIYC.
