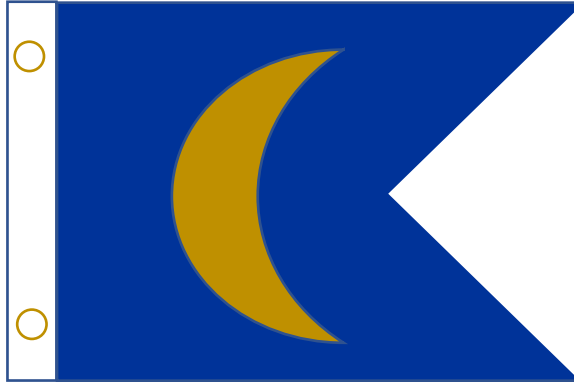


NOTICE OF RACE

1 RULES

The regatta will be governed by the rules as defined in The Racing Rules of Sailing 2009 - 2012.

2 ELIGIBILITY AND ENTRY

2.1 Entrants will be divided in the following categories

2.1.1 Class A Displacement

2.1.2 Class B Planning

2.1.3 Spinnakers must be registered prior to the Captains meeting

2.1.4 Any boat that uses a Spinnaker during the race but did not indicate it on the registration form will be disqualified.

2.2 A minimum of three boats will constitute a class

2.3 Eligible boats may enter by completing the attached form and sending it,

together with the required fee, by September 30, 2023 to

3 FEES

3.1 Required fees are as follows:

- All classes \$40.00

3.2 Other fees:

- \$5.00 discount off the registration fee for US Sailing, SAIL or CCYC memberships.]

4 SCHEDULE OF EVENTS

4.1 Registration:

Friday September 29 at 3 Bananas from 6pm till 8 pm.

Saturday, September 30 at 3 Bananas from 8:00 am till 10:00 am.

4.2 Date of Racing: Saturday, September 30

Captains meeting @ 10:15 3 Bananas

4.3 Start sequence at 10:55 Race committee will signal boats over early at the start in accordance with the RRS

4.4 Trophy presentation @ 1700 (5:00pm) at 3 Bananas

5 VENUE

The regatta will be held on Lake Crescent in Crescent City, Florida.

6 SAILING INSTRUCTIONS

The sailing instructions will be available after 1800 on September 29, 2023

7 COURSE

7.1 Courses will be contained in the sailing instructions.

7.2 Course is long distance race.

7.3 Course will be windward-leeward marks north and south of Bear Island. The length of the course will be approximately 12 nautical miles.

7.4 Course may change in length due to wind conditions and weather

8 SCORING

8.1 One race is required to be completed to constitute a series.

8.2 All boats will be scored Portsmouth according to U.S. Sailing

8.3 Boats who use a Spinnaker will change their Portsmouth rating and must be registered before the Captains meeting

8.4 Any boat that uses a Spinnaker during the race but did not indicate it on the registration form will be disqualified.

9 SUPPORT BOATS

9.1 Support Boats will be marked with a CCYC flag.

10. PRIZES

10.1 Over All Champion Will Receive the Golden Goat Head

10.2 First Place winners will have their name engraved on the Golden Goat Head plaque at 3 Bananas

10.3 Trophies will be awarded for 1st, 2nd and 3rd place finishers of their class.

11 BERTHING

11.1 Slips are available at 3 Bananas 11 South Lake Street, Crescent City, FL and at the Margary Neal Nelson Sunrise Park and Boat Ramp 107 Cypress Street, Crescent City Florida 32112

11.2 Contact 3 Bananas at (386)698-2861 for information on slips.

11.3 Launching and set up can be done at two areas; on Central Avenue and the Margery Neal Sunshine Park by the Crescent City Water Tower

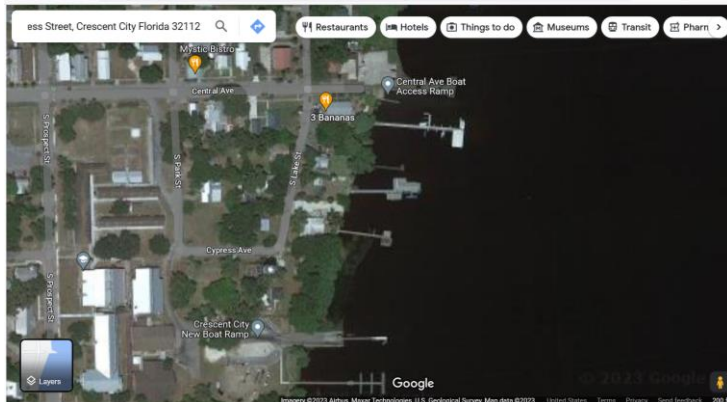


Figure 1: Boat Ramps - the Marery Neal is listed as the Crescent City New Boat Ramp
