### 1. Rules

1.1. The race will be governed by the rules as defined in The Racing Rules of Sailing 2021-2024 unless otherwise amended in this Notice of Race or the Sailing Instructions.

### 2. Advertising

2.1. Competitor advertising will not be restricted.

### 3. Eligibility and Entry

3.1. The regatta is open to all yachts that are members of HYRA member clubs, and other yachts that may be invited by the organizing authorities.

### **6. Measurements**

6.1. Each boat shall have a valid YRA / NCPHRF handicap rating or may be assigned a temporary rating by the organizing authority.

### **7. Sailing Instructions**

7.1. Sailing instructions will be available at the skippers meeting and on Regatta Network.

### **8. Venue**

8.1. The race will be held in the waters around Oahu.

### **9. Scoring**

9.1. Staggered start times will be calculated using PHRF Time on Distance scoring system.

### **10. Prizes**

10.1. For each class a first prize will be awarded if at least three boats enter, second prize will be awarded if at least five boats enter, and third prize will be awarded if at least seven boats enter.

### **11. Disclaimer of Liability**

11.1. The responsibility for a boat's decision to participate in a race or the continue racing is hers alone. See RRS Rule 4, Decision to Race. The organizing authority will not accept liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.

### **12. Insurance**

12.1. Each participating boat shall be insured with valid third-party liability insurance with a minimum cover of \$500,000 per event or the equivalent. A copy of certificate will be required at time of registration.
